PART I

BILLS INTRODUCED OCTOBER - DECEMBER 2011

DOGS (AMENDMENT) BILL 2011

The Bill, promoted by the Department of Environment, Food and Agriculture, amends the Dogs Act 1990 to clarify the effect of that Act or to make deregulatory changes. Clauses 1, 2 and 3 concern the short title, commencement and the introduction of the amendments. Clause 4 clarifies that an order under section 1(2) may provide an exemption from duty or for a lower rate of duty when a dog is fitted with an electronic transponder (microchip). Clause 5 substitutes section 2 to provide greater flexibility in the granting of exemptions. Clause 6 extends the power in section 24 to enable byelaws about dog fouling to apply to car parks, cemeteries and churchyards. Clause 7 amends Schedule 1 so that the Department may specify the colour of a tag to be worn by a licensed dog rather than prescribing a colour by means of an order approved by Tynwald. Clause 8 makes consequential amendments and removes spent provisions in other enactments. Clauses 1 and 2 operative on passing - remaining provisions require appointed day order made by DEFA after consultation with Department of Infrastructure. COURT FEES ORDER 2011

[SD 592/11 : Commencement : 01/11/11 : Issuing Authority - Treasury]

The Order clarified certain fees and applied GC 250/90 concerning the remission of fees on matters before the High Court and Courts of Summary Jurisdiction.

GOVERNMENT

TRANSFER OF FUNCTIONS (GOVERNOR IN COUNCIL) ORDER 2011

[SD 861/11 : Commencement : 21/10/11 : Issuing Authority - Governor in Council]

The Order transferred the functions of the Governor in Council under various Acts and Orders to the Council of Ministers including the appointment of members to Government Departments and the Communications Commission.

PROCEEDS OF CRIME

PROCEEDS OF CRIME (EXTERNAL INVESTIGATIONS) ORDER 2011

[SD 862/11 : Commencement : 01/01/12 : Issuing Authority - CoM]

The Order allowed for court orders and warrants equivalent to those for domestic investigations under the Proceeds of Crime Act 2008 to be used where investigations are undertaken on behalf of overseas authorities. Like offences and penalties are also applied. Operative for the making of subordinate legislation 21 October 2011.

SURVEILLANCE

REGULATION OF SURVEILLANCE (PRESCRIPTION OF OFFICES, RANKS AND POSITIONS) (AMENDMENT) ORDER 2011

[SD 832/11 : Commencement : 21/10/11 : Issuing Authority - DHA]

The Regulations prescribed public authority officers who may authorise surveillance.

TAXATION

INCOME TAX (REPEAL OF THE ATTRIBUTION REGIME FOR INDIVIDUALS) ORDER 2011

[SD 847/11 : Commencement : 21/10/11 : Issuing Authority - Treasury]

For distributable profits accrued by corporate taxpayers after 6 April 2012 the Order repealed ss 12 to 13M Income Tax Act 1970 which established the Attribution Regime for Individuals and introduced measures to prevent the avoidance of ARI.

JUDGMENTS (RECIPROCAL ENFORCEMENT) (UNITED KINGDOM AND CHANNEL ISLANDS) ORDER 2011

[SD 930/11 : Commencement : 01/12/11 : Issuing Authority - CoM]

The Order extended the application of Part I {registration of judgments given outside the Island} of the Judgments (Reciprocal Enforcement) (Isle of Man) Act 1968 to the United Kingdom, Jersey and Guernsey. Also specified are the courts of the jurisdictions that are recognised courts for the purposes of Part I.

RULES OF THE HIGH COURT OF JUSTICE (AMENDMENT) (No.3) 2011

[SD 954/11 : Commencement : 01/12/11 : Issuing Authority - FSC]

The Rules make summary procedure the normal procedure on claims for possession of land and embody in the 2009 Rules Practice Directions 1 and 2 of 2010 which concerned judgments in a foreign currency and costs in small claims.

FINANCIAL SERVICES

FINANCIAL SERVICES (EXEMPTIONS) REGULATIONS 2011

[SD 885/11 : Commencement : 01/01/12 : Issuing Authority - FSC]

The Regulations set out the exemptions from s 4 Financial Services Act 2008 which prohibits the carrying on of regulated activities without a licence.

FINANCIAL SERVICES RULE BOOK 2011

[SD 886/11 : Commencement : 01/01/12 : Issuing Authority - FSC]

The Rule Book is for the holders of licences under the Financial Services Act 2008 when carrying out regulated activities. The main changes concern Class 8 (money transmission services), e-money being moved to Class 8 and Part 9 (professional officers) simplified.

REGULATED ACTIVITIES ORDER 2011

[SD 884/11 : Commencement : 01/01/12 : Issuing Authority - Treasury]

The Order specified the activities which constitute “regulated activities” under Financial Services Act 2008 and defined expressions found in s 1(2) of that Act.

FOUNDATIONS

FOUNDATIONS (CONTINUANCE) REGULATIONS 2011

[SD 1008/11 : Commencement : 01/01/12 : Issuing Authority - Treasury]

The Regulations provide for the continuance in the Island of foreign foundations and for Manx foundations to be continued in another jurisdiction subject to meeting certain criteria.

FOUNDATIONS (FEES) REGULATIONS 2011

[SD 1009/11 : Commencement : 01/01/12 : Issuing Authority - Treasury]

The Regulations require the Registrar of Foundations to consult with the Treasury before setting any fees under the Foundations Act 2011 and such fees must be laid before Tynwald as a Government Circular.

FOUNDATIONS (WINDING UP) REGULATIONS 2011

[SD 1006/11 : Commencement : 01/01/12 : Issuing Authority - Treasury]

The Regulations provide for the winding up of foundations together with matters to be considered.

INSURANCE

INSURANCE (SOLVENCY) (AMENDMENT) REGULATIONS 2011

[SD 918/11 : Commencement : 31/12/11 : Issuing Authority - IPA]

The Regulations provided for the treatment of contingent debt assets when calculating the minimum margin of solvency of an insurer and extended the period of admissibility of certain debt assets for the same calculation.

MONEYLENDERS

MONEYLENDERS (EXEMPT PERSONS) REGULATIONS 2011

[SD 944/11 : Commencement : 15/12/11 : Issuing Authority - IOMOFT]

The Regulations replace the existing regulations.

PENSIONS

PENSION SCHEMES LEGISLATION (APPLICATION) (No. 2) ORDER 2011

[SD 927/11 : Commencement : As UK : Issuing Authority - DSC]

The Order is consequential on the abolition of contracting-out for defined contribution pension schemes and the abolition of protected rights.

REVENUE
