The Concession ensures that a person receiving child benefit, income support or *employed person's allowance [*replacement benefit for family income supplement and disability working allowance] is not subject to income tax unless they have other income which exceeds their personal allowance. It does not apply if the spouse or civil partner of an individual has had their liability to income tax capped. It is intended in the future to include the concession in primary legislation.
