Explanatory Note:	<p>This Order brings into operation for all purposes the specified provisions of the <i>Criminal Justice, Police Powers and Other Amendments Act 2014</i> with effect from 1 January 2015 as follows –</p> <ul style="list-style-type: none"> <li>• section 3, as this section allows for the ultimate expiry of the <i>Criminal Justice, Police Powers and Other Procedures Act 2014</i> once all of its provisions are in operation;</li> <li>• section 14, as it amends section 22 of the <i>Criminal Justice Act 1991</i> to allow for searches of one or more premises and for such searches to be allowed on one or more occasions;</li> <li>• section 22, as this section gives effect to the amendments to be made to the <i>Police Powers and Procedures Act 1998</i> (PPP) by the Act;</li> <li>• sections 23 to 29, as these sections provide for the amendment of sections 11, 18, 19 and Schedule 1 of the PPP along with the insertion of new section 11A, Part IIA and Schedules 1A and 1B into the PPP, with regard to new vires for search warrants and the associated additional powers of seizure;</li> <li>• section 30, as this section gives effect to the substitutions to be made to sections 27 and 28 of the PPP, the insertion of a new section 28A into the PPP and the consequential amendments to other Acts with regard to powers of arrest;</li> <li>• section 33, as this section amends section 40 of the PPP to redefine a juvenile as a person under the age of 18;</li> <li>• section 34, as this section inserts a new section 49A into the PPP to permit suspected drug offenders to be remanded to the custody of a constable;</li> <li>• section 37, as this section substitutes section 55 of the PPP to amend the application of Part IV of the PPP to children;</li> <li>• section 38, as this section amends section 58 of the PPP with regard to who authorises such searches and inserts a definition of “juvenile” for the purposes of this section;</li> <li>• section 39, as it inserts a new section 58A into the PPP to provide for x-rays and ultrasound scans of persons suspected of swallowing or concealing Class A drugs;</li> <li>• section 41, as it amends section 64 of the PPP to allow for fingerprints to be taken elsewhere that at a police station;</li> </ul>

- Explanatory Note:    This Order brings into operation the Act, which re-enacts with slight amendment provisions in the *Terrorism (Finance) Act 2009* and the *Terrorism Asset-Freezing etc. Act 2010 (of Parliament)* as applied by the *Terrorism Asset-Freezing etc. Act 2010 (Isle of Man) Order 2011* together with certain provisions in the *Anti-Terrorism and Crime Act 2003* so that all the provisions concerned with controlling the financing of terrorism and related matters are brought together into one Act. Schedule 4 details the repeals performed by the Act.
- The Order also contains two transitional provisions to maintain the statutory indemnity of the Financial Supervision Commission and Insurance and Pensions Authority under this Act as these bodies hold with regard to the *Terrorism (Finance) Act 2009*.

In future the Attorney General's functions will be capable of being discharged by the holder of that office, the Solicitor General or a person appointed by a warrant under Her Majesty's Royal Sign Manual to discharge those functions.

The Order removes the duplicated words where they first occur in order to give the Order its proper effect.

The remaining provisions of the Act came into effect on 1<sup>st</sup> December 2014 with the exception of section 16 (financial assessment), section 21 (deferred payment of care accommodation costs and power to charge land in lieu of contributions) and paragraphs 5(3) and 10 of Schedule 3 (which contains consequential amendments).  
Section 32 of the Act (short title and commencement) came into operation on the announcement of Royal Assent to Tynwald on 13<sup>th</sup> December 2011.

**SD 2015/0303      Representation of the People (Amendment) Act 2015 (Appointed Day No.1) Order 2015**

Commencement:      See Articles 3 & 4 of the Order

Explanatory Note:      This Order brings into operation the whole of the *Representation of the People (Amendment) Act 2015* other than –

- (a) section 6, to the extent that it imposes a requirement that an officeholder in a political party should be a registered elector in a constituency in the Island;
- (b) section 23, which would have replaced section 40 of the *Representation of the People Act 1995* ("the 1995 Act") on the prohibition on the use of licensed premises as committee rooms for elections with a more general provision; and
- (c) section 35, which amends the modifications of the 1995 Act in respect of local elections.

The Order also makes transitional provision in respect of references to section 10B elsewhere in the 1995 Act as amended to reflect the fact that, by virtue of the exception mentioned at (a), not all of section 6 is brought into operation.

Generally, this Order applies only to the 2016 General Election and any subsequent election to the House of Keys: the amendments made by the 2015 Act will not apply to any by-election to the existing House of Keys. Accordingly, the existing law will continue to apply to any by-election to the existing House. The exception to this rule is that section 34, which repeals some spent transitional provisions in the 1995 Act, is commenced for all purposes.

- Explanatory Note:    Sections 1 and 2 of the Public Health (Tobacco) (Amendment) Act 2015 came into operation on the announcement of Royal Assent at the October 2015 sitting of Tynwald. This Order provides for the commencement of the remaining provisions, which come into operation on the day after of the making of the Order for the purposes of making secondary legislation (article 2(a)), on 9 March 2016 for the purposes of sections 20, 21,22, 24 and 25 (insofar as they are not already in operation) (article 2(b)) and on 1 July 2016 for all other purposes (article (2(c)).
- The effect of the Order is to bring the Act into operation the provisions which are the responsibility of the Department of Environment, Food and Agriculture for all substantive purposes on 9 March 2016 (National No-Smoking Day 2016). Regulations and orders relating to those provisions may be made before that day but come into operation then. Provisions which are the responsibility of the Department of Health and Social Care are being introduced in a way that allows those in the tobacco supply chain to make the necessary changes to premises and practices in consequence of the new restrictions on sale and display imposed by virtue of the amendments to the Public Health (Tobacco) Act 2006.

The Order also brings into operation section 30 of the Act so far as it relates to the amendments made by section 99(8). Section 99(8) contains amendments to the Building Control Act 1991: those amendments commenced on the announcement of Royal Assent.
