Appointed Day Orders laid before Tynwald – January 2017

SD 2016/0378 Custody (Amendment) Act 2016 (Appointed Day) Order 2016

Tynwald Sitting January 2017

Made: 6 December 2016

Explanatory Note: This Order brings into operation sections 5, 6, 7, 8(2), 8(4), 11, 12 and 15 of the Custody (Amendment) Act 2016 with effect from 7 December 2016. Article 3 also brings sections 8(1), 9 and 10 of that Act, into operation with effect from 7 December 2016, for the purpose of allowing the Department to make custody rules. It also brings section 14 of that Act into effect from 7 December 2016, for the purpose of allowing the Chief Registrar to make arrangements for the appointment of court security officers and empowering the Deemsters to make rules regarding court security.

Article 4 provides for sections 8(3), 9 (Security of Institutions) and 10 (Testing for drugs etc.) of the Custody (Amendment) Act 2016, and the associated Schedule to that Act as it inserts a new Schedule 1A (Security of Institutions) into the Custody Act 1995, to come fully into operation with effect from 1 February 2017.

Article 5 of the order provides for transitional measures to ensure that –

- a person cannot be convicted of an offence under the new schedule 1A to the Custody Act 1995, as given effect by section 9 of the Custody (Amendment) Act 2016 and the Schedule, before 1 February 2017;
- detainees are not subject to the tests made by section 19A of the Custody Act 1995, as given effect by section 10 of the Custody (Amendment) Act 2016, before 1 February 2017; and
- revocations of licences granted under paragraph 8(4) of Schedule 2 to the Custody Act 1995 (as given effect by section 11(2) of the Custody (Amendment) Act 2016) cannot be granted before 7 December 2016.

Article 6 provides that section 8 of the Custody (Amendment) Act 2016, in so far as it is not already in operation by virtue of articles 3(d), 3(e), 3(f) and 4(a), comes into operation on 1 April 2017. This will be at the same time as amendments to the Custody Rules 2015 regarding the appointment and functions of independent adjudicators are to come into effect.
