### **Appointed Day Orders laid before Tynwald – February 2017**

<b>SD 2017/0048</b>	<b>Highways (Amendment) Act 2016 (Appointed Day) (No.1) Order 2017</b>
Tynwald Sitting	February 2017
Made:	30 January 2017
Explanatory Note:	<p>This Order brings into operation, with effect from 1 February 2017, all sections of the <i>Highways (Amendment) Act 2016</i> except sections 14, 24, 25 and 33. Of the affected sections, section 9 is brought into operation only partially. The effect of this is that only the Department will be permitted to exercise the powers conferred by subsection (1) of the new section 32A that the <i>Highways (Amendment) Act 2016</i> inserts into the <i>Highways Act 1986</i>.</p> <p>Additionally, this Order contains a transitional provision, pursuant to which applications for licences which were made to local authorities before 1 February 2017 but are yet to be determined must be determined without regard to whether or not the Department consents to the grant of the licence.</p> <p>The transitional provision is necessary because the version of section 78 in operation before the making this Order requires Departmental consent to the grant of a licence, whereas the version of section 78 substituted by the <i>Highways (Amendment) Act 2016</i> dispenses with the need for Departmental consent.</p> <p>Accordingly, where an application for a licence was submitted under the old section 78 but was not determined before the new section 78 came into operation, the determination of that application is to be in accordance with the new section 78. In such an instance, the Department must disregard any application that had already been referred to it for consent by the time the new section 78 comes into operation. The local authority must autonomously determine any such application.</p>

## **Tynwald Resolution**

In accordance with section 119 of the Income Tax Act 1970, Tynwald resolved –

- (1) That the personal allowance -
  - (a) in respect of two persons who are spouses or civil partners of each other under subsection (1) of section 35 of that Act shall be £25,000;
  - (b) in respect of individuals under each of paragraphs (a), (b), (ba), and (c) of subsection (3) of that section shall be £12,500.
- (2) That the age allowance under subsection (1) of section 43B of that Act shall be £0.
- (3) That this resolution shall apply in respect of the income tax year commencing 6th April 2017 and subsequent years.
