AN ACT to make further provision about elections to the Legislative Council; and for connected purposes.

*Received Royal Assent: 21 March 2017*  
*Announced to Tynwald: 21 March 2017*  
Commencement: Whole Act by Appointed Day Order

The remaining sections of the Criminal Procedure and Investigations Act 2016, which have not already come into operation, commence from 1 April 2017.

Explanatory Note:      This Order amends the Custody (Amendment) Act 2016 (Appointed Day) Order 2016 [SD 2016/0378] to change the commencement of section 8 of the Custody (Amendment) Act 2016, in so far as it is not already in operation, from 1 April 2017 to 1 July 2017.
