Royal Assent announced to Tynwald April 2017

AT 2 of 2017 Treasure Act 2017

AN ACT to abolish treasure trove; to make fresh provision with respect to the determination of whether found objects are treasure; and for connected purposes.

Signed in Tynwald: 25 April 2017

Received Royal Assent: 25 April 2017

Announced to Tynwald: 25 April 2017

Commencement: Sections 1 & 2 on passing; remainder by Appointed Day Order

AT 3 of 2017 Beneficial Ownership Act 2017

AN ACT to make provision about the beneficial ownership of certain legal entities; and for connected purposes.

Signed in Tynwald: 25 April 2017

Received Royal Assent: 25 April 2017

Announced to Tynwald: 25 April 2017

Commencement: Sections 1 & 2 on passing; remainder by Appointed Day Order

Explanatory Note: This Order brings the Legislative Council Elections Act 2017 into operation on 5 April 2017. The effect of that Act is to enable the Standing Orders of the Keys to provide for the procedure by which elected Members of Legislative Council are to be elected (the Lord Bishop and the Attorney General are both *ex officio* members).

SD 2017/0143 Alcoholic Liquor Duties Act 1986 (Section 71F) (Appointed Day) Regulations 2017

Tynwald Sitting April 2017

Made: 5 April 2017

Explanatory Note: These Regulations appoint 1 April 2017 as the day for section 71F of the Alcoholic Liquor Duties Act 1986 (“the Act”) to come into operation.

The Alcoholic Liquor Duties Act 1986 (Amendment) Order 2015 inserted a new Part VIA (sections 71A to 71K) into the Act, the new Part containing a scheme requiring approval by the Treasury of persons engaged in the wholesaling of controlled liquor. The necessary definitions of wholesaling of controlled liquor are contained in section 71A(2) and (3) of the Act, with “controlled liquor” being dutiable alcoholic liquor charged at a duty-rate greater than nil, and where the duty point for the liquor was at or before the time of the sale.

Section 71F imposes a restriction on buying controlled liquor wholesale from an Island or United Kingdom person unless that person is an approved person in relation to the sale. An approved person would be one approved under section 71C of the Act in the Island, or under section 88C of the Alcoholic Liquor Duties Act 1979 (an Act of Parliament) in the United Kingdom.

Bringing section 71F of the Act into operation means that all the amendments made by the Alcoholic Liquor Duties Act 1986 (Amendment) Order 2015 are now in operation.
