Explanatory This Order brings into operation subparagraphs (1) and (2) of paragraph Note: 121 of Schedule 14 to the Civil Partnership Act 2011. These provisions

amend the definition of "near relative" in section 8 of the Disability

Discrimination Act 2006 to include civil partners.

SD 2017/0175 Police (Amendment) Act 2016 (Appointed Day) (No.2) Order 2017

Made: 10 May 2017

Explanatory This Order brings into operation sections 4 and 6 of the Police

Note: (Amendment) Act 2016 with effect from 12 May 2017.

Section 4 of the Police (Amendment) Act 2016 inserts a new section 77B (police powers for contracted staff) and Schedule 2A (contracted staff) into the Police Powers and Procedures Act 1998 with regard to the

contracting out of police powers.

Section 6 of the Police (Amendment) Act 2016 amends section 12(5) of the Police Act 1993 (Police Federation) so that references to members of the

police force in that section include special constables.
