 Effective: 21 June 2017

SD 2017/0177 **Beneficial Ownership Act 2017 (Appointed Day) Order 2017**
 Tynwald Sitting June 2017
 Made: 16 May 2017
 Explanatory Note: This Order brings the remaining provisions of the Beneficial Ownership Act 2017 into operation (either with immediate effect or from 21 June 2017), other than section 43 which provides for the compulsory online submission of annual returns by companies. Sections 1 and 2 of that Act came into operation upon the announcement of Royal Assent.

SD 2017/0194 **Beneficial Ownership Act 2017 (Appointed Day) (No.2) Order 2017**
 Tynwald Sitting June 2017
 Made: 30 May 2017
 Explanatory Note: This Order brings section 4(4), (7) and (8) of the Beneficial Ownership Act 2017 into operation so as to enable the Isle of Man Financial Services Authority to issue guidance as to the meaning of beneficial owner.

 Tynwald Sitting June 2017
 Made: 06 June 2017
 Explanatory Note: This Order brings into operation the majority of the provisions of the Tynwald Commissioner for Administration Act 2011, subject to transitional modifications and savings.
