AT 5 of 2017 **Equality Act 2017**
AN ACT to reform and harmonise equality law; to increase equality of opportunity; to make further provision about employment law; and for connected purposes.
Signed in Tynwald: 18 July 2017
Received Royal Assent: 18 July 2017
Announced to Tynwald: 18 July 2017

Commencement: Sections 1 & 2 on passing; remainder by Appointed Day Order

AT 6 of 2017 **Insurance (Amendment) Act 2017**
AN ACT to amend the Insurance Act 2008; and for connected purposes.

Commencement: Sections 1, 2 & 3 on passing; remainder by Appointed Day Order

AT 7 of 2017 **Fraud Act 2017**
AN ACT to make provision for, and in connection with, criminal liability for fraud and obtaining services dishonestly; and for connected purposes.
Signed in Tynwald: 18 July 2017
Received Royal Assent: 18 July 2017
Announced to Tynwald: 18 July 2017

Commencement: Sections 1 & 2 on passing; remainder by Appointed Day Order

AT 8 of 2017 **Income Tax Legislation (Amendment) Act 2017**
AN ACT to confirm certain temporary taxation orders; to amend various enactments relating to income tax; and for connected purposes.

Signed in Tynwald: 18 July 2017

Received Royal Assent: 18 July 2017

Announced to Tynwald: 18 July 2017

Commencement: Section 9 in operation 6 April 2017; remainder on passing

AT 9 of 2017 **Police (Detention and Bail) Act 2017**
AN ACT to make provision about the calculation of certain periods of time for the purposes of Part IV of the Police Powers and Procedures Act 1998.
