### **Royal Assent announced to Tynwald – October 2017**

**AT 10 of 2017      Statute Law Revision Act 2017**

**AN ACT** to make minor amendments to the Legislation Act 2015, the Interpretation Act 2015 and other enactments; to repeal spent and redundant enactments; and for connected purposes.

*Signed in Tynwald: 17 October 2017*

*Received Royal Assent: 17 October 2017*

*Announced to Tynwald: 17 October 2017*

Commencement: Whole Act in operation on the first day of the month following that in which Royal Assent to it is announced.

- (b) for all other purposes, on 1 January 2018.

- Explanatory Note:      This Order brings into operation, on the day following the making of the Order, the following provisions of Schedule 22 to the Equality Act 2017 —
- (a) paragraph 29(4), and paragraph 29(1) so far as it relates to paragraph 29(4); and
- (b) paragraph 33 insofar as it is not already in operation.
- It also revokes the entries in article 7 of SD 2017/0221 relating to those paragraphs in consequence of their being brought into operation earlier than 1 January 2018.
