Explanatory Note:	This Order brings section 7 (relinquishment of Holy Orders) of the Church Offices Measure (Isle of Man) 2011 into operation on 1 December 2017. The rest of the Measure (except section 5) was brought into force on 1 August 2011, and section 5 was brought into force on 15 October 2011, by the Church Offices Measure (Isle of Man) 2011 (Appointed Day) (No. 1) Order 2011 (SD 625/11)..
