## **Acts of Tynwald**

### **Royal Assent announced to Tynwald – January 2018**

**AT 1 of 2018      Casino (Amendment) Act 2018**

**AN ACT** to permit the revocation of a licence in cases of non-compliance with money laundering and financing of terrorism legislation; to permit the premises in which casinos are located and the facilities and amenities provided under casino licences to be varied; to permit the Council of Ministers additional discretion in relation to deposits for concessions; and for connected matters.

*Received Royal Assent: 16 January 2018*

*Announced to Tynwald: 16 January 2018*

Commencement: Sections 1, 2 & 3 on passing; remainder by Appointed Day Order.

**AT 2 of 2018      Gambling (Anti-Money Laundering and Countering the Financing of Terrorism) Act 2018**

**AN ACT** to provide the necessary powers to conduct regulatory oversight of the gambling sector's compliance with Anti-Money Laundering and Countering the Financing of Terrorism legislation; to provide sanctions for non-compliance; and for connected purposes.

*Received Royal Assent: 16 January 2018*

*Announced to Tynwald: 16 January 2018*

Commencement: Sections 1 & 2 on passing; remainder by Appointed Day Order.

### **Appointed Day Orders laid before Tynwald – January 2018**

**SD 2017/0382      Interpretation Act 2015 (Appointed Day) (No.1) Order 2017**

Tynwald Sitting      January 2017

Made:                      20 December 2017

Explanatory Note:      This Order provides for the coming into operation of the bulk of the provisions of the Interpretation Act 2015 on 1 January 2018. The provisions which are not commenced relate to the proposed electronic gazette. The Order makes transitional provision in respect of deputies and acting appointments in place on commencement.

**SD 2017/0383      Legislation Act 2015 (Appointed Day) (No.2) Order 2017**

Tynwald Sitting      January 2017

Made:                      20 December 2017

Explanatory Note:      This Order brings into operation the bulk of the Legislation Act 2015 (“the 2015 Act”).  
Certain formal provisions commenced on the announcement of Assent, along with section 80 (a declaratory provision about the status of notes in the text of statutes), 92 (which concerns the status of existing reprints of Manx Statutes published by Juta & Co. Limited or Blackhall Publishing) and section 99(8) which amended the Building Control Act 1991. The first Appointed Day Order (SD 2015/266) brought into operation the remainder of section 99 (a miscellaneous collection of minor amendments to statutes).  
The only provisions of the 2015 Act which are not being commenced now relate to the operation of the electronic gazette (see section 43 and the provisions of sections 19(4), 26(1), 44, 91 and 98 and Schedule 2 so far as they relate to the gazette) and section 10(1) so far as it requires a certificate of the announcement of Royal Assent to include a reference to the time of announcement.
