Royal Assent announced to Tynwald – March 2018

AT 4 of 2018 Dogs (Amendment) Act 2018

AN ACT to amend the Dogs Act 1990 to impose a requirement for every dog on the Island to have implanted in it a microchip; to require the keeper of every dog on the Island to ensure that the dog is microchipped; to abolish the licensing and duty regime for dogs on the Island; and for connected purposes.

Signed in Tynwald: 20 March 2018

Received Royal Assent: 20 March 2018

Announced to Tynwald: 20 March 2018

Commencement: Sections 1 & 2 on passing; remainder by Appointed Day Order.

AT 5 of 2018 Road Transport, Licensing and Registration (Amendment) Act 2018

AN ACT to amend the Road Transport Act 2001 and the Licensing and Registration of Vehicles Act 1985.

Signed in Tynwald: 20 March 2018

Received Royal Assent: 20 March 2018

Announced to Tynwald: 20 March 2018

Commencement: Part 1 on passing; remainder by Appointed Day Order.

AT 6 of 2018 Council of Ministers (Amendment) Act 2018

AN ACT to amend the Road Transport Act 2001 and the Licensing and Registration of Vehicles Act 1985.

Signed in Tynwald: 16 January 2018

Received Royal Assent: 20 March 2018

Announced to Tynwald: 20 March 2018

Commencement: Whole Act on passing.
