## **Acts of Tynwald**

### **Royal Assent announced to Tynwald – July 2018**

**AT 12 of 2018      Airports and Civil Aviation (Amendment) Act 2018**

**AN ACT** to amend the Airports and Civil Aviation Act 1987 to provide enabling powers for the making of Isle of Man secondary legislation that is not derived from related secondary legislation enacted in the United Kingdom; to authorise the enactment of Isle of Man secondary legislation that gives effect to international obligations of the Island in relation to civil aviation; and for connected purposes.

*Announced to Tynwald: 17 July 2018*

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

**AT 13 of 2018      Central Registry Act 2018**

**AN ACT** to establish the Central Registry; to create the office of Registrar General; to transfer certain functions of the General Registry to the Central Registry, the Registrar General and the Treasury; to make minor amendments to the law on the registration of interests in land; to provide for the Criminal Injuries Compensation Scheme; and for connected purposes.

*Received Royal Assent: 17 July 2018*

*Announced to Tynwald: 17 July 2018*

Commencement: Sections 1 and 2 on passing under the Legislation Act 2015; remainder by Appointed Day Order.

### Appointed Day Orders laid before Tynwald – July 2018

<b>SD 2018/0190</b>	<b>Anti-Money Laundering and Other Financial Crime (Miscellaneous Amendments) Act 2018 (Appointed Day) Order 2018</b>
Tynwald Sitting	July 2018
Made:	20 June 2018
Explanatory Note:	This Order brings the remaining provisions of the Anti-Money Laundering and Other Financial Crime (Miscellaneous Amendments) Act 2018 into operation with effect from 21 June 2018. Sections 1 and 2 came into operation on the announcement of Royal Assent.

**SD 2018/0194 Equality Act 2017 (Appointed Day No. 4) Order 2018**

Tynwald Sitting July 2018

Made: 29 June 2018

Explanatory Note: This Order brings into operation the provisions of Schedule 24 to the Equality Act 2017 to the extent necessary to effect the repeal of –

- section 9 of the Chronically Sick and Disabled Persons Act 1981; the definition of "the Advisory Council" in section 16 of the 1981 Act;
- section 4 of the Chronically Sick and Disabled Persons (Amendment) Act 1992; and
- paragraphs 2, 3, 4 and 6 of Schedule 5 to the Disability Discrimination Act 2006.

The provisions repealed in the latter two Acts made minor amendments to sections 9 and the definition of the "Advisory Council" in section 16 of the 1981 Act. The combined effect of the repeals is to abolish the Tynwald Advisory Council for Disabilities.

The Order also revokes a provision in Schedule 3 to the Equality Act 2017 (Appointed Day No. 3 and Transitional Provisions) Order 2017 (SD 2017/0384) which becomes unnecessary as a result of the commencement of the repeals contained in article 2 and listed above.
