Acts of Tynwald

Royal Assent announced to Tynwald – January 2019

AT 1 of 2019 Abortion Reform Act 2019

AN ACT to restate the law relating to abortion with amendments; to make provision about access zones for premises where abortion services and related counselling are provided and for premises occupied by those providing such services and counselling; and for connected purposes.

Signed in Tynwald: 15 January 2019

Received Royal Assent: 15 January 2019

Announced to Tynwald: 15 January 2019

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

AT 2 of 2019 European Union and Trade Act 2019

AN ACT to repeal the European Communities (Isle of Man) Act 1973; to make provision consequent upon the withdrawal of the United Kingdom from the EU and the resultant cessation of Protocol No. 3 to the Act annexed to the Treaty relating to the Accession of the United Kingdom to the European Economic Community and to the European Atomic Energy Community signed at Brussels on the 22 January 1972; to make provision to apply EU law to, and to implement EU law in, the Island after exit day; to make provision to apply to the Island UK legislation relating to the United Kingdom's withdrawal from the EU and the United Kingdom's future relationship with the EU and relating to the functions of the Department of Environment, Food and Agriculture; to make provision in relation to trade and trade agreements; and for connected purposes.

Commencement: Sections 1 to 4, 12 to 25, 27 and 28(1) to (4) on passing; remainder by Appointed Day Order.

Tynwald Sitting January 2019
Made: 14 December 2018
Explanatory Note: This Order appoints 1 March 2019 as the day on which the Safeguarding Act 2018 (AT 7 of 2018) comes into operation.

SD 2018/0329 Equality Act 2017 (Appointed Day) (No.5) Order 2018
Tynwald Sitting January 2019
Made: 14 December 2018
Explanatory Note: This Order replaces the provision made by the Equality Act 2017 (Appointed Day No. 3 and Transitional Provisions) Order 2017 (SD 2017/0384: “the principal Order”) so far as provisions commencing on 1 January 2019 and 1 January 2020.
Article 1 deals with the title of the Order and article 2 with the interpretation of terms used in it. “The Act” in this Order, and in this Note means the Equality Act 2017 (AT 5 of 2017).
Article 3 revokes articles 4 and 5 of, and Schedules 2 and 3 to, the principal Order.
Article 4 gives effect to Schedules 1 to 4 of the current Order and contains a declaratory provision on the effect of the Order, those Schedules and the provisions commenced by them in relation to discrimination on grounds of age and disability or in respect of the concept of work of equal value (in relation to which the provisions of the Act commence on 1 January 2020 for all purposes).
Article 5 explains the status of italic entries in the Schedules. These relate to provisions commenced previously or to provisions which are not to be commenced.
Article 6 makes it clear that nothing in article 4 or the Schedules dependent upon it applies in the case of the protected characteristics of age or disability or in relation to work of equal value before 1 January 2020.
Schedule 1 contains the major part of the commencement provisions but Schedules 2, 3 and 4 deal specifically with the commencement of the provisions of Schedules 22, 23 and 24 to the Act. These deal respectively with amendments to employment law, consequential amendments flowing from the main provisions of the Act and repeals.
