Acts of Tynwald

Royal Assent announced to Tynwald – February 2019

AT 3 of 2019 Payment of Members' Expenses Act 2019

An ACT to amend the Payment of Members' Expenses Act 1989 to make provision for a member of Tynwald who is suspended from Tynwald or a Branch of Tynwald to cease to receive certain payments and expenses; and for connected purposes.

Signed in Tynwald: 19 February 2019

Received Royal Assent: 19 February 2019

Announced to Tynwald: 19 February 2019

Commencement: Whole Act on passing.

AT 4 of 2019 Criminal Evidence Act 2019

AN ACT to make fresh provision about evidence in criminal proceedings, and for 1 connected purposes

Signed in Tynwald: 19 February 2019

Received Royal Assent: 19 February 2019

Announced to Tynwald: 19 February 2019

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

Acts repealed – February 2019

 Explanatory This Order brings into operation various provisions of the European
 Note: Union and Trade Act 2019.

SD 2019/0063 Safeguarding Act 2018 (Appointed Day) (Amendment) Order 2019
 Tynwald Sitting February 2019
 Made: 01 February 2019
 Explanatory This Order amends the Safeguarding Act 2018 (Appointed Day) Order
 Note: 2018. The effect is to exclude section 9(1)(b) of the 2018 Act from the
 provisions commenced on 1st March 2019. The excluded paragraph
 relates to the Child Death Overview Panel, which is chaired by the
 Island's Director of Public Health. Although included in the Act as a
 committee of the Safeguarding Board, this Panel performs functions
 which relate to public health rather than safeguarding. It is anticipated
 that the relevant paragraph will be repealed in due course. The Panel will
 continue to exist, however, under the aegis of the Department of Health
 and Social Care.
