Explanatory Note:	This Order brings all the provisions of the Credit Unions (Amendment) Act 2018 into operation.

<b>SD 2019/0123</b>	<b>Abortion Reform Act 2019 (Appointed Day) Order 2019</b>
Tynwald Sitting	March 2019
Made:	22 February 2019
Explanatory Note:	This Order brings the Abortion Reform Act 2019 (“the Act”) into operation. For the purpose of making statutory documents, directions, guidelines and documents required under the Act, section 6 (abortion services – conditions for provision), section 12 (duties of medical professional following termination), section 17 (regulations), section 19 (access zones – hospitals and other premises where terminations are performed or counselling is provided), section 21 (access zones – homes of persons providing abortion services or counselling), section 22 (access zones – maximum dimensions) and section 26 (access zones – notices) come into operation immediately after the Order is made. The Act comes into operation for all other purposes on 24 May 2019.
