### **SD 2019/0144 Criminal Evidence Act 2019 (Appointed Day) Order 2019**

Tynwald Sitting April 2019

Made: 25 March 2019

Explanatory Note: This Order brings the Criminal Evidence Act 2019 into operation on 1 May 2019 in respect of criminal proceedings commenced on or after that date. It also contains a transitional provision which disapplies sections 53 and 54 of the Criminal Justice Act 2001 (which made other provisions about the admissibility of evidence of bad character) in relation to cases which the 2019 Act's rules will apply, in order to prevent a conflict between the different approaches taken by the two Acts.

**SM 2 of 2019      Ecclesiastical Jurisdiction and Care of Churches Measure (Isle of Man) 2019**

A MEASURE enacted pursuant to the Church Legislation Procedure Act 1993 to extend to the Island certain provisions of the Ecclesiastical Jurisdiction and Care of Churches Measure 2018; and for connected purposes

*Received Royal Assent: 9 April 2019*

*Announced to Tynwald: 9 April 2019*

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.
