## **Acts of Tynwald**

### **Royal Assent announced to Tynwald – June 2019**

#### **AT 5 of 2019      Highways (Amendment) Act 2019**

**An ACT** to amend the Tynwald procedure in respect of certain orders amending the definitive maps for rights of way and associated statements, to amend the definition of "planning approval" for the purposes of the Highways Act 1986; and for connected purposes..

*Signed in Tynwald: 18 June 2019*

*Received Royal Assent: 18 June 2019*

*Announced to Tynwald: 18 June 2019*

Commencement: Whole Act on passing.

#### **AT 6 of 2019      Dormant Assets Act 2019**

**AN ACT** to provide for the establishment of a fund into which the balances of certain dormant assets may be transferred; and for the distribution of money in that fund for charitable and other purposes, subject to a right to reclaim those balances from the fund; and for connected purposes.

*Received Royal Assent: 18 June 2019*

*Announced to Tynwald: 18 June 2019*

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

The following Appointed Day Order was laid at the June 2019 sitting of Tynwald.

### **SD 2019/0223 Central Registry Act 2018 (Appointed Day) (No.1) Order 2019**

Tynwald Sitting June 2019

Made: 29 May 2019

Explanatory Note: This Order commences certain provisions of the Central Registry Act 2018.

Article 1 provides for the title of the Order and article 2 for the meaning of “the Act”.

Article 3 provides for provisions connected with the establishment of the office of the Registrar General to come into operation on 20 May 2019.

Article 4 provides for the commencement of all other provisions (except paragraphs 23 and 33(13) of the Schedule) on 1 July 2019. The provisions which are not commenced will in due course be repealed: the former will be replaced by alternative provision, and the latter has proved to be unnecessary.

Article 5 contains a transitional provision to address the fact that the Registrar General will be discharging other functions as a member of the General Registry until 1 July 2019.
