AT 7 of 2019 **Charities Registration and Regulation Act 2019**
AN ACT to repeal and replace the *Charities Registration Act 1989*; to make further provision for the registration and regulation of charities; and for connected purposes.
Signed in Tynwald: 16 July 2019
Received Royal Assent: 16 July 2019
Announced to Tynwald: 16 July 2019
 Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

AT 8 of 2019 **Council of Ministers (Amendment) Act 2019**
AN ACT to uphold and support the rule of law, and the independence of the judiciary, on the Island; and for connected purposes.
Signed in Tynwald: 16 July 2019
Received Royal Assent: 16 July 2019
Announced to Tynwald: 16 July 2019
 Commencement: Whole Act in operation at the beginning of the month following that in which Royal Assent to it is announced to Tynwald.

Tynwald Sitting	July 2019
Made:	19 June 2019
Explanatory Note:	This Order brings the Dormant Assets Act 2019 (“the Act”) into operation immediately after the Order is made for the purposes of making orders and regulations under provisions dealing with the following: exemption from being a licenceholder under the Act (section 6(3)); the requirements for the notices of dormant assets (section 15(6)) and transfer of assets (section 16(8)) under the Act; annual statements of repayments (section 20(3)); notices and procedures in respect of reclaim certificates (section 21(4)); and the requirements for notices and transfer of assets dormant at the commencement of the Act (sections 33(3), 34(3) and 35(4)). This Order also brings the Act into operation for all remaining purposes on 1 July 2019.
