Acts of Tynwald

Royal Assent announced to Tynwald – October 2019

AT 9 of 2019 Income Tax Legislation (Amendment) Act 2019

AN ACT to confirm certain temporary taxation orders; to amend the Income Tax Act 1970; and for connected purposes..

Signed in Tynwald: 8 October 2019

Received Royal Assent: 8 October 2019

Announced to Tynwald: 8 October 2019

Commencement: Whole Act in operation on passing.

AT 10 of 2019 Town and Country Planning (Amendment) Act 2019

AN ACT to amend the Town and Country Planning Act 1999 to make provision for national policy directives; to clarify the matters for which provision may be made in a development procedure order; to clarify the circumstances in which an application for planning approval may be referred to the Council of Ministers; to require that any independent inspector's report relevant to such a referral be laid before Tynwald; to provide an enabling power for a community infrastructure levy; to provide for the constitution of the planning committee; to amend section 40 of that Act; to define general importance; and for connected purposes.

Received Royal Assent: 8 October 2019

Announced to Tynwald: 8 October 2019

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

SD 2019/0270 Ecclesiastical Jurisdiction and Care of Churches Measure (Isle of Man) 2019 (Appointed Day) (No. 1) Order 2019

Tynwald Sitting October 2019

Made: 4 June 2019

Explanatory Note: This Order brings the Ecclesiastical Jurisdiction and Care of Churches Measure (Isle of Man) 2019 into operation on 1 July 2019, except so far as it relates to the constitution of the Diocesan Advisory Committee.

SD 2019/0381 Charities Registration and Regulation Act 2019 (Appointed Day) Order 2019

Tynwald Sitting October 2019

Made: 24 September 2019

Explanatory Note: This Order brings into operation certain provisions of the Charities Registration and Regulation Act 2019 on 1 October 2019, namely the widening of the definition of “charity” and “charitable purpose”; automatic disqualification for acting as a charity trustee; creation of the register of charity mergers; creation of the Charities Tribunal (in order that it can be established prior to 1 April 2020); power to make regulations; matters concerning the submission of incomplete documents or ones including false and misleading statements; supplementary provisions concerning offences; records keeping; publication of approved forms; disclosure to or by the Attorney General and some consequential amendments to other Acts. The remaining provisions of the Act are brought into operation on 1 April 2020.
