Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

AT 5 of 2020 Isle of Man Loans (Amendment) Act 2020

**AN ACT** to amend the Isle of Man Loans Act 1974 to make provision about the borrowing powers of Government; the

consolidated loans fund; borrowing authorities; and for connected

purposes.
