Royal Assent announced to Tynwald – October 2020

- AT 10 of 2020 **Divorce, Dissolution and Separation (Isle of Man) Act 2020****
AN ACT to make, in relation to marriage and civil partnership, provision about divorce, dissolution and separation; and for connected purposes.
Signed in Tynwald: 20 October 2020
Received Royal Assent: 20 October 2020
Announced to Tynwald: 20 October 2020
Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.
- AT 11 of 2020 **Registration of Electors Act 2020****
AN ACT to restate the enactments relating to the franchise and the registration of electors; to amend the law relating to the maintenance of electoral registers; and for connected purposes.
Signed in Tynwald: 20 October 2020
Received Royal Assent: 20 October 2020
Announced to Tynwald: 20 October 2020
Commencement: Sections 1, 2 and 3 on passing; remainder by Appointed Day Order.
- AT 12 of 2020 **Domestic Abuse Act 2020****
AN ACT to make fresh provision about domestic abuse; to make consequential and minor amendments to the Land Registration Act 1982 and for connected purposes.
Signed in Tynwald: 20 October 2020
Received Royal Assent: 20 October 2020
Announced to Tynwald: 20 October 2020
Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.
- AT 13 of 2020 **Public Housing Act 2020****
AN ACT to revoke the Sale of Houses Regulations 1958 with retrospective effect; and for connected purposes.
Signed in Tynwald: 20 October 2020
Received Royal Assent: 20 October 2020
Announced to Tynwald: 20 October 2020
Commencement: Whole Act on passing.
- AT 14 of 2020 **Elections (Keys and Local Authorities) Act 2020****
AN ACT to repeal and replace the Representation of the People Act 1995 and the Local Elections Act 1986; to consolidate in a single enactment provisions equivalent to those made by the two aforementioned Acts; and for connected purposes.

Received Royal Assent: 20 October 2020
Announced to Tynwald: 20 October 2020

Commencement: Sections 1, 2 and 3 on passing; remainder by Appointed Day Order.

SD 2020/0400 Licensing (Amendment) Act 2020 (Appointed Day) Order 2020

Tynwald Sitting October 2020

Made: 22 July 2020

Explanatory This Order brings the Licensing (Amendment) Act 2020 into operation
 Note: on 23 July 2020. The Act makes amendments to the Licensing Act 1995
 and the Music and Dancing Act 1961 by deferring the triennial session
 from before end of March 2021 to before end of March 2022. This Act
 also permits, until the end of September 2020, any portion of the
 highway which is adjacent to licensed premises to be treated as part of
 the licensed premises if a pavement licence is granted.

**SD 2020/0442 Ecclesiastical Jurisdiction and Care of Churches Measure (Isle of
 Man) 2019 (Appointed Day) (No. 2) Order 2020**

Tynwald Sitting October 2020

Made: 28 September 2020

Explanatory This Order brings the remaining provisions of the Ecclesiastical
 Note: Jurisdiction and Care of Churches Measure (Isle of Man) 2019 into
 force on 21 October 2020.
 The effect of those provisions is to replace the existing constitution of
 the Sodor and Man Diocesan Advisory Committee with a new
 constitution, set out in Schedule 2 to the Ecclesiastical Jurisdiction and
 Care of Churches Measure 2018 (as modified in its application to the
 Isle of Man).
 The other provisions of the 2019 Measure were brought into force on
 1 July 2019 by the Ecclesiastical Jurisdiction and Care of Churches
 Measure (Isle of Man) 2019 (Appointed Day) (No. 1) Order 2019 (SD
 2019/270).
