Royal Assent announced to Tynwald – December 2020

AT 17 of 2020 Income Tax Act 2020

AN ACT to confirm certain temporary taxation orders and to amend the Income Tax Act 1970 so as to enable regulations to be made which provide for debts relating to any relevant foreign tax pursuant to arrangements having effect by virtue of section 104E.

Signed in Tynwald: 15 December 2020

Received Royal Assent: 15 December 2020

Announced to Tynwald: 15 December 2020

Commencement: Whole Act on passing.

AT 18 of 2020 Courts, Tribunals and Local Authority Procedures, and Miscellaneous Provisions Act 2020

AN ACT to make provision about procedures under the Criminal Justice Police and Courts Act 2007, the Police Powers and Procedures Act 1998 and the Criminal Law Act 1981, and Local Authority procedures in respect of meetings, to make provision in respect of the vacation of Departmental facilities, to amend the Public Health Act 1990; and for connected purposes.

Received Royal Assent: 15 December 2020

Announced to Tynwald: 15 December 2020

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

SD 2020/0570 Limitation (Childhood Abuse) Act 2020 (Appointed Day) Order 2020

Tynwald Sitting: December 2020

Made: 4 December 2020

Explanatory Note: This Order brings into operation the sections of the Limitation (Childhood Abuse) Act 2020 (“the Act”) which are not already in operation: sections 1 and 2 of the Act came into operation on the announcement of Royal Assent. Section 3 of the Act makes amendments to the Limitation Act 1984 to remove the limitation period for actions of damages in respect of personal injuries resulting from childhood abuse.

SD 2020/0591 Courts, Tribunals and Local Authority Procedures, and Miscellaneous Provisions Act 2020 (Appointed Day) Order 2020

Tynwald Sitting: December 2020

Made: 15 December 2020

Explanatory Note: This Order brings section 28 of the Courts, Tribunals and Local Authority Procedures, and Miscellaneous Provisions Act 2020 into operation immediately after it is made and the rest of the Act into operation immediately before the lapse of the Emergency Powers (Coronavirus) (Continuation) (No. 2) Regulations 2020. The Act makes provision about procedures under the Criminal Justice Police and Courts Act 2007, the Police Powers and Procedures Act 1998 and the Criminal Law Act 1981 in respect of the use of live audio and video links in proceedings and for the use of bail with conditions. It also deals with Local Authority procedures in respect of meetings, makes provision in respect of the vacation of Departmental facilities and amends the Public Health Act 1990 and the Emergency Powers Act 1936.
