### **Royal Assent announced to Tynwald – February 2021**

**AT 1 of 2021      Gas Regulation (Amendment) Act 2021**

**AN ACT** to amend the Gas Regulation Act 1995 to confer the power to set parameters within which a public gas supplier may fix tariffs, and for connected purposes.

*Signed in Tynwald: 16 February 2021*

*Received Royal Assent: 16 February 2021*

*Announced to Tynwald: 16 February 2021*

Commencement: Whole Act on passing.

A MEASURE enacted pursuant to the Church Legislation Procedure Act 1993 to extend to the Isle of Man the Ecumenical Relations Measure 2018, the Church of England (Miscellaneous Provisions) Measure 2018 and the Church of England (Miscellaneous Provisions) Measure 2020; and for connected purposes.

*Approved by Tynwald: 16 November 2020*  
*Received Royal Assent: 16 February 2021*  
*Announced to Tynwald: 16 February 2021*
