Manx Care Act 2021

AN ACT to establish Manx Care; to confer duties on it in connection with the functions it discharges; and for connected purposes..

Signed in Tynwald: 16 March 2021

Received Royal Assent: 16 March 2021

Announced to Tynwald: 16 March 2021

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

Explanatory

This Order. This Order brings the majority of the Manx Care Act 2021 into force on 1 April 2021.

Note:

Certain sections of the Act are being brought in earlier to allow:

a) the Manx Care (Duty of Candour Procedure) Regulations 2021 that are to be made under section 11 to be made and approved by Tynwald ahead of coming into operation on the same date that Manx Care is established;

b) the Regulations in relation to complaints and the Independent Review Body constituted under the National Health Service Act 2001 and Social Services Act 2011 to be updated to include reference to complaints made about Manx Care, in preparation for the establishment of Manx Care;

c) the mandate to Manx Care under section 14 to be laid before Tynwald before Manx Care is established;

d) the non-executive members of Manx Care to be approved by Tynwald before Manx Care is established.

Explanatory Note:	This Order brings the Church (Miscellaneous Provisions) Measure (Isle of Man) 2021 into operation on 1 April 2021. The main effect of the Measure is to extend to the Isle of Man with modifications the Ecumenical Relations Measure 2018, the Church of England (Miscellaneous Provisions) Measure 2018 and the Church of England (Miscellaneous Provisions) Measure 2020. Excluded from commencement are provisions which are dependent on canonical provisions yet to be enacted.

Explanatory Note:	This Order brings into operation the provisions of the Elections (Keys and Local Authorities) Act 2021[1] so far as they relate to holding national elections on 1 March 2021. The provisions in respect of local elections will come into operation on 1 January 2022.
