Commencement: Sections 1, 2, 9, 152 and 153 on passing; remainder by Appointed Day Order.

Medicines (Amendment) Act 2021

AN ACT to regulate the administration, sale and supply of medicinal products; and for connected purposes.

Signed in Tynwald: 20 April 2021

Received Royal Assent: 20 April 2021

Announced to Tynwald: 20 April 2021

Commencement: Whole Act on passing.

Elections and Meetings (Local Authorities) Act 2021

AN ACT to change the date on which local elections in 2021 are due to take place and to enable meetings of local authorities to take place remotely; and for connected purposes.
