### **Royal Assent announced to Tynwald – June 2022**

The following Act had Royal Assent announced at the June 2022 sitting of Tynwald.

**AT 1 of 2022      Manx Care (Amendment) Act 2022**

**AN ACT** to amend the Manx Care Act 2021 so as to enable the Department of Health and Social Care to make updated provision in respect of complaints in respect of services provided and functions performed under the National Health Service Act 2001, the Social Services Act 2011 and the Children and Young Persons Act 2001.

*Received Royal Assent: 21 June 2022*

*Announced to Tynwald: 21 June 2022*

Commencement: Whole Act on passing.

Tynwald Sitting	June 2022
Made:	10 May 2022
Explanatory Note:	<p>This Order brings into operation, on the day after this Order is made, the following provisions of the Climate Change Act 2021 (“2021 Act”), but only for purposes connected to the making of regulations under section 29 (regulation of single use plastics) –</p> <ul style="list-style-type: none"> <li>(a) section 30(3) (which provides for the power for regulations or orders to create offences);</li> <li>(b) section 32 (powers of entry); and</li> <li>(c) section 33 (regulations and orders: fixed penalties).</li> </ul> <p>This order also brings into operation, on the day after this Order is made, paragraph 2 (which makes amendments to the Licensing and Registration of Vehicles Act 1985) and paragraph 5 (which makes amendments to the Customs and Excise Act 1993) of the Schedule to the 2021 Act, and section 37 to the extent required to bring those paragraphs into operation.</p>

 A MEASURE enacted pursuant to the Church Legislation Procedure Act 1993 to extend to the Isle of Man the Safeguarding (Code of Practice) Measure 2021; and for connected purposes.

*Approved by Tynwald: 15 March 2022*  
*Received Royal Assent: 21 June 2022*  
*Announced to Tynwald: 21 June 2022*  
 Commencement: Whole Act by Appointed Day order.
