Explanatory Note:	This Order brings into operation sections 2(3), 88 to 102, 103(1), (2), (3), (6) and (7), 104 to 108 and 110 to 113 of the Justice Reform Act 2021 on the day after this order is made. Sections 1 and 2(1) and (2) of the Justice Reform Act 2021 came into operation on the Act's announcement day (20 July 2021).

Made:	8 September 2022
Explanatory Note:	This Order brings the Safeguarding (Code of Practice) Measure (Isle of Man) 2022 into operation on 1 January 2023. The Order also makes transitional provision to keep in operation any guidance made by the House of Bishops on matters relating to safeguarding children and vulnerable adults pending its replacement by a code of practice under the new section 5A of the Safeguarding and Clergy Discipline Measure 2016.
