Made:	11 October 2022
Explanatory Note:	This Order brings into operation the following sections of the Communications Act 2021 – sections 5 and 6; sections 8, 10, 11, 140, and 154 in so far as they are not already in operation; section 14; sections 36 to 59; sections 61 to 65; sections 126 to 129; section 141; Schedules 1 and 9 in so far as they are not already in operation; Schedules 2 and 3.

This Order also provides for the continuation in force of a licence granted under section 2 (licensing of programme services) of the Broadcasting Act 1993 and the continuation in force of the Code of Advertising and Sponsorship (last amended on 2 September 2003) and The Programme Code (last revised in Summer 2004), which were made under the Broadcasting Act 1993.

The provisions of the Communications Act 2021 that have not yet been brought into operation are sections 66 to 68 and Schedule 4.
