SD 2023/0099 Marriage Measure (Isle of Man) 2022 (Appointed Day) Order 2023

Tynwald Sitting March 2023

Made: 23 February 2023

Explanatory Note: This Order brings the Marriage Measure (Isle of Man) 2022 into operation on 1 July 2023.

SD 2023/0100 Church (Miscellaneous Provisions) Measure (Isle of Man) 2021 (Appointed Day) (No. 2) Order 2023

Tynwald Sitting March 2023

Made: 23 February 2023

Explanatory Note: This Order brings the remaining provisions of the Church (Miscellaneous Provisions) Measure (Isle of Man) 2021 into operation on 1 July 2023. They concern a definition of "religious community", and amendments relating to electronic registers of church services, which were dependent on canonical provisions now in force. The rest of the Measure was brought into force on 1 April 2021 by SD 2021/0085.
