The following Acts had Royal Assent announced at the April 2023 sitting of Tynwald.

AT 1 of 2023 Capacity Act 2023

AN ACT to make provision relating to the property, financial affairs and health and welfare of persons who lack capacity and for establishing the principles to be applied for such purposes, for lasting powers of attorney, and for connected purposes.

Received Royal Assent: 25 April 2023

Announced to Tynwald: 25 April 2023

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.

AT 2 of 2023 Energy Act 2023

AN ACT to amend the Energy Act 1980; to amend the Gas Regulation Act 1995; and for connected purposes.

Signed in Tynwald: 25 April 2023

Received Royal Assent: 25 April 2023

Announced to Tynwald: 25 April 2023

Commencement: Sections 1 and 2 on passing; remainder by Appointed Day Order.
