Royal Assent announced to Tynwald – May 2023

No Acts had Royal Assent announced at the May 2023 sitting of Tynwald.

Acts repealed – May 2023

No Acts were wholly repealed in May 2023.

The following Appointed Day Order was laid at the May 2023 sitting of Tynwald.

SD 2023/0134	Divorce, Dissolution and Separation (Isle of Man) Act 2020 (Appointed Day) Order 2023
Tynwald Sitting	May 2023
Made:	31 March 2023
Explanatory Note:	This Order brings into operation the remaining provisions of the Divorce, Dissolution and Separation (Isle of Man) Act 2020 (the “Act”), other than – <ul style="list-style-type: none"> (a) paragraph 7 of the Schedule to the Act to the extent that it inserts section 13B(2) into the Matrimonial Proceedings Act 2003; and (b) paragraph 9(3) and (4) of the Schedule to the Act. Sections 1 and 2 came into operation upon the Act’s announcement day, by virtue of section 18 of the Legislation Act 2015; and section 8(2) came into operation on the same day by virtue of section 2(2) of the Act. Article 4 makes transitional provision to disapply various provisions of the Act where proceedings have started before the 3 April 2023, so that those proceedings continue under the Matrimonial Proceedings Act 2003 and the Civil Partnership Act 2011 as those Acts stood before their amendment by the Act.
