## Acts of Tynwald

### Royal Assent announced to Tynwald – April 2024

The following Acts had Royal Assent announced at the April 2024 sitting of Tynwald.

**AT 2 of 2024      Sanctions Act 2024**  
**AN ACT** to provide for the implementation in the Island of United Kingdom sanctions provisions; to amend the Terrorism and Other Crime (Financial Restrictions) Act 2014 so as to align certain provisions more closely with equivalent provisions of United Kingdom law; and for connected purposes.  
*Signed in Tynwald: 16 April 2024*  
*Received Royal Assent: 16 April 2024*  
*Announced to Tynwald: 16 April 2024*  
 Commencement: Sections 1 and 2 on passing, remainder by Appointed Day Order.

**AT 3 of 2024      Income Tax Act 2024**  
**AN ACT** to confirm the Income Tax (Personal Allowance) (Temporary Taxation) Order 2023; to amend the Income Tax Act 1970; and for connected purposes..  
*Signed in Tynwald: 16 April 2024*  
*Received Royal Assent: 16 April 2024*  
*Announced to Tynwald: 16 April 2024*  
 Commencement: Whole Act on passing.

### Acts repealed –April 2024

No Acts were wholly repealed in April 2024.

The following Appointed Day Order was laid at the April 2024 sitting of Tynwald.

**SD 2024/0108      Sexual Offences and Obscene Publications Act 2021 (Appointed Day) (No. 2) Order 2024**  
 Tynwald Sitting      April 2024  
 Made:                      22 March 2024  
 Explanatory Note:      This Order brings into operation the remainder of the Sexual Offences and Obscene Publications Act 2021 (“the 2021 Act”) on 25 March 2024, except –  
                                     (a)      section 87 (duty to notify police of possible victims of child sexual abuse), which will come into operation immediately upon the making of regulations under that

- section that prescribe a safeguarding policy for the purposes of that section; and
- (b) paragraph 13 of Schedule 5 (which amends section 36(3) of the Licensing Act 1995, which has been repealed since the passing of the 2021 Act).

Sections 1 and 2 of the 2021 Act came into operation on its announcement day. Part 11 (pardons and disregards) of the 2021 Act was brought into operation on 29 June 2022.

Article 4 makes supplementary provisions, Articles 5 and 6 make transitional provisions and Articles 7 and 8 make savings provisions (see SD 2024/0108 for details).
