### **Royal Assent announced to Tynwald – May 2024**

The following Act had Royal Assent announced at the May 2024 sitting of Tynwald.

**AT 4 of 2024      Vaping Products Act 2024**

**AN ACT** to make provision in respect of the manufacture of vaping products, the composition of vaping liquids and the sale, importation, advertising and promotion of such products; and for connected purposes..

*Signed in Tynwald: 21 May 2024*

*Received Royal Assent: 21 May 2024*

*Announced to Tynwald: 21 May 2024*

Commencement: Sections 1 and 2 on passing, remainder by Appointed Day Order.

Explanatory Note:      This Order brings into operation the provisions of the Animal Welfare Act 2023 that are yet to be commenced, i.e. all the provisions other than sections 1 and 2 (which came into operation immediately upon Royal Assent being announced). In exercise of the power conferred by section 2, the Department saves specified Codes and Orders made under the Animal Health Act 1996..
