PRE-REVESTMENT WRITTEN LAWS (ASCERTAINMENT) ACT 1978

Received Royal Assent: 21 March 1978
Passed: 20 June 1978
Commenced: 20 June 1978

AN ACT to repeal certain obsolete laws enacted or made prior to Revestment; to specify which of the pre-Revestment laws are still in force and to provide short titles therefor; and for matters connected therewith.

1 Clarification of residue of pre-Revestment written laws

Those provisions of the written laws mentioned in the first and second columns of the Schedule which are specified in the third column shall continue to have effect as if this Act had not been passed.¹

2 Provision of short titles for laws mentioned in the Schedule

Each written law mentioned in the first and second columns of the Schedule may be cited by the short title appearing opposite thereto in the fourth column of the Schedule.

3 and 4 [Repealed]²

5 Short title

This Act may be cited as the Pre-Revestment Written Laws (Ascertainment) Act 1978.
