EUROPEAN UNION AND TRADE ACT 2019 (MODIFICATION) (SANCTIONS) (NO. 2) REGULATIONS 2019¹

Approved by Tynwald: 18th June 2019
Coming into Operation: in accordance with regulation 2

The Council of Ministers makes the following Regulations under section 12 of, and paragraph 2(2) of Schedule 5 to, the European Union and Trade Act 2019.

1 Title

These Regulations are the European Union and Trade Act 2019 (Modification) (Sanctions) (No. 2) Regulations 2019.

2 Commencement

If approved by Tynwald, these Regulations come into operation on IP completion day^{1,2}

3 [Revoked]³

4 Modification of retained EU law

- (1) The EU Regulations specified in the Schedule (the “**specified EU regulations**”) have been applied to the Island, as part of the law of the Island, by statutory documents made under section 2A of the European Communities (Isle of Man) Act 1973 (to such extent and subject to such exceptions, adaptations and modifications as are specified in those statutory documents).
- (2) The specified EU regulations are further modified in their application to the Island as follows —
 - (a) if appropriate, references in the specified EU regulations to “Member State” and “Member States”, “the Community” and “the

Union” shall be read as if the United Kingdom were a Member State and its territory were included within the territory of the Union; and

- (b) if appropriate, references in the specified EU regulations to “competent authority” shall be read as including the appropriate authority in the United Kingdom.

5 Continuation of existing ambulatory references

Any reference —

- (a) in a statutory document made under section 2A of the European Communities (Isle of Man) Act 1973 which applies a specified EU regulation to the Island; and
- (b) which is a reference to an Annex to a specified EU regulation as amended from time to time or to a provision of a specified EU regulation as amended from time to time,

is to be read, on and after IP completion day, as a reference to that Annex or provision as amended from time to time by EU law.⁴

6 Construction

To avoid doubt, any retained EU law is to be construed and have effect subject to these Regulations.⁵
