EMERGENCY POWERS (CORONAVIRUS) (CLOSURE OF BUSINESSES AND OTHER PREMISES) REGULATIONS 2020¹

The Governor in Council, by Order¹, makes the following Regulations under section 4 of the Emergency Powers Act 1936².

1 Title

These Regulations are the Emergency Powers (Coronavirus) (Closure of Businesses and Other Premises) Regulations 2020.

2 Commencement

These Regulations come into operation at 6.30 a.m. on 27 March 2020.

3 Interpretation

(1) In these Regulations —

“**Coronavirus**” means severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2);

“**the Coronavirus Proclamation period**” means the period for which the following proclamations are in operation —

(a) the Proclamation of Emergency dated 16 March 2020³; and

- (b) all subsequent consecutive Proclamations of Emergency that relate to the pandemic of Coronavirus (also known as COVID-19);²

“**Department**” means the Department of Education, Sport and Culture;³

“**immediate family**” in relation to a person (P) means the P’s spouse or civil partner, a person living in an enduring family relationship with P, P’s child, parent or grandparent, grandchild, brother, sister, half-brother or half-sister or a child of P’s family;⁴

“**enclosed spaces in parks**” means a wholly or partly enclosed space in a public park, pleasure ground, recreation ground, garden, beach or other grounds to which the public are permitted access whether on payment or otherwise and includes a playground or play area;⁵

“**places of worship**” means any church, chapel or other building used for public religious worship and includes a burial ground, a Sunday or Sabbath school and any building attached to or used in connection with such a church, chapel or other building; and

“**premises**” includes any place, ship, aircraft, vehicle, stall or movable structure;

“**sporting facility**” means any premises used for or at which sporting activities are played, held or otherwise take place and includes facilities which serve such premises; and⁶

“**vulnerable person**” includes —

- (a) any person who is pregnant;
- (b) any person aged 70 or older; and
- (c) any person under 70 who has an underlying health condition, including but not limited to —
 - (i) chronic (long-term) respiratory diseases, such as asthma, chronic obstructive pulmonary disease, emphysema or bronchitis;
 - (ii) chronic heart disease, such as heart failure;
 - (iii) chronic kidney disease;
 - (iv) chronic liver disease, such as hepatitis;
 - (v) chronic neurological conditions, such as Parkinson’s disease, motor neurone disease, multiple sclerosis;
 - (vi) a learning disability or cerebral palsy;
 - (vii) diabetes;
 - (viii) problems with the spleen, such as sickle cell disease or removal of the spleen;
 - (ix) a weakened immune system as the result of conditions such as HIV and AIDS, or medicines; such as steroid tablets or chemotherapy;

- (x) being seriously overweight, with a body mass index of 40 or above.
- (2) In these Regulations —
 - (a) a person who is responsible for carrying on a business includes the owner, proprietor, and manager of that business; and
 - (b) a person who is responsible for premises includes the owner, proprietor, and manager of the premises.

4 Requirement to cease operating certain businesses

- (1) A person who is responsible for carrying on a business listed in Part 1 of the Schedule must cease operating the business immediately and for the remainder of the Coronavirus Proclamation period.
- (2) A person who is responsible for the premises of any business listed in Part 1 of the Schedule must immediately and for the remainder of the Coronavirus Proclamation period close the premises.
- (3) If a business listed in Part 1 of the Schedule (“business A”) forms part of a larger business (“business B”), the person responsible for carrying on business B complies with the requirement in paragraph (1) if it closes down business A.
- (4) Paragraphs (1) and (2) are subject to regulation 5B.⁷

5 Continuation of operation of certain businesses

- (1) A person may during the Coronavirus Proclamation period continue operating a business at premises described in an entry in the first column of the table in Part 2 of the Schedule —
 - (a) only for the purpose described in the corresponding entry in the second column of the table in that Part; and
 - (b) only if the person does so in compliance with the conditions (if any) contained in the corresponding entry in the third column of the table in that Part.
- (1A) Paragraph (1) is subject to regulation 5B.⁸
- (2) A person may continue operating a business of a type described in Part 3 of the Schedule.
- (3) If a business continues operating during the Coronavirus Proclamation period, the person who is responsible for carrying on the business must ensure that the business adopts such measures as are reasonably practicable to reduce the risk of a person being infected with Coronavirus as a result of being present at the premises of that business or being in contact with a person from that business, including —
 - (a) ensuring so far as it practicable that persons at the premises are able to remain at least 2 metres away from any other person;

- (b) ensuring that the premises are regularly and frequently cleaned; and⁹
 - (c) ensuring that facilities are provided for enabling persons at the premises to clean or otherwise sanitise their hands frequently; and
 - (d) complying with any guidance issued and published for the purpose of this paragraph by the Department for Enterprise.^{10 11}
- (4) The person responsible for carrying on a business that is not required under these Regulations to close —
- (a) may only require the presence of such employees whose attendance is necessary for the proper performance of his or her office, employment or vocation at the business premises or such other premises as the employee would ordinarily be expected to attend in the course of his or her office, employment or vocation; and¹²
 - (b) must ensure that no more persons are present at any one time than is necessary for the effective operation of the business on a sustained basis.^{13 14}

5A Directions

- (1) During the Coronavirus Proclamation period, the Department may give a direction that applies to —
- (a) one or more sporting facilities;
 - (b) sporting facilities in the Island (or any part of the Island) generally; or
 - (c) sporting facilities in the Island (or any part of the Island) of a particular description.
- (2) A direction under this regulation is a direction by which a person responsible for carrying on a sporting facility —
- (a) may be required to close a sporting facility generally or for specified purposes; or
 - (b) may be permitted to open a sporting facility generally or for the purposes of one or more sporting activities, with or without conditions.
- (3) A direction under this regulation may —
- (a) require a person responsible for carrying on a sporting facility to take reasonable steps in connection with the opening of a sporting facility in general terms, or require the taking of particular steps that the Department considers reasonable;
 - (b) relate to attendance at the sporting facility of persons generally, or to attendance by specified persons;

- (c) relate to sporting facilities generally, or to specified sporting facilities or parts of sporting facilities;
 - (d) relate to attendance at a sporting facility for purposes connected with sporting activities generally, or a specified sporting activity;
 - (e) otherwise make different provision for different purposes, or be framed by reference to whatever matters the Department considers appropriate; and
 - (f) include such other provision as the Department considers appropriate in connection with the giving of the direction.
- (4) If a direction under paragraph (2)(b), permits a sporting facility to open for any reason during the Coronavirus Proclamation period, the person who is responsible for carrying on the sporting facility must ensure that the sporting facility adopts such measures as are reasonably practicable to reduce the risk of a person being infected with Coronavirus as a result of being present at the sporting facility or being in contact with a person from or at that sporting facility, including —
- (a) ensuring so far as it practicable that persons at the sporting facility are able to remain at least 2 metres away from any other person;
 - (b) ensuring that the sporting facility is regularly and frequently cleaned;
 - (c) ensuring that facilities are provided for enabling persons at the sporting facility to clean or otherwise sanitise their hands frequently;
 - (d) requiring the presence only of such employees whose attendance is necessary for the proper performance of his or her office, employment or vocation at the sporting facility or such other premises as the employee would ordinarily be expected to attend in the course of his or her office, employment or vocation; and
 - (e) ensuring that no more persons are present at any one time than is necessary for the effective operation of the sporting facility.
- (5) A direction under this regulation must be published by the Department on www.gov.im.
- (6) A direction under this regulation has effect until the earlier of —
- (a) the end of the period specified in the direction; or
 - (b) the revocation of the direction by a further direction given by the Department under this regulation.¹⁵

5B Exemptions from regulations 4 and 5

- (1) Despite regulations 4 and 5, where —
 - (a) the Chief Minister announces that a business or premises to which paragraph (2) applies, is to be permitted to reopen from a specified

date in the future, either generally or for a particular purpose and with or without conditions or restrictions; and

- (b) details of the announcement are published on www.gov.im for the purpose of this regulation,

the person responsible for the business or premises may reopen the business or premises for the purposes specified and to the extent provided for in paragraph (3).

- (2) This paragraph applies to —
 - (a) a business listed in Part 1 of the Schedule;
 - (b) the premises of any business listed in Part 1 of the Schedule;
 - (c) a business or premises described in an entry in the first column of the table in Part 2 of the Schedule.
- (3) A person referred to in paragraph (1) may reopen a business or premises to which paragraph (2) applies, and permit the presence of such employees whose attendance is necessary, only to the extent necessary to allow —
 - (a) in the case of a business or premises to which paragraph (2)(a) or (b) applies, preparations to be made in readiness for the business to reopen; and
 - (b) in the case of a business or premises to which paragraph (2)(c) applies, preparations to be made in readiness for the business to open for a purpose or to an extent over and above that provided for in the second column of the table in Part 2 of the Schedule.
- (4) In making the preparations referred to in paragraph (3), the person referred to in paragraph (1) may only permit a person, whose attendance is necessary in connection with the preparations to enter or work in the business or premises.
- (5) A person responsible for a business or premises to which this regulation applies must comply with —
 - (a) regulation 5(3) and (4); and
 - (b) any guidance issued for the purpose of this regulation by the Department for Enterprise and published on www.gov.im.¹⁶

6 Enforcement

- (1) Compliance with these Regulations or a direction made under regulation 5A may be enforced by —
 - (a) a constable; or
 - (b) any other person, or description of person, designated for the purpose of this regulation by the Department of Health and Social Care or the Department of Home Affairs.¹⁷

- (2) In exercising the power of enforcement conferred by paragraph (1), a person may –
 - (a) enter any premises; and
 - (b) if necessary, use reasonable force.

7 Offences and penalties

- (1) A person who, without reasonable excuse, contravenes regulation 4, 5 or 5B or a direction made under regulation 5A commits an offence.¹⁸
- (2) A person who obstructs, without reasonable excuse, any person carrying out a function under these Regulations commits an offence.
- (3) Maximum Penalty (summary) - 3 months' custody and a fine not exceeding level 5 on the standard scale.
- (4) If a person is alleged to have contravened regulation 5 or 5B or a direction under regulation 5A, regard may be given, when determining whether the person is guilty of the offence, as to whether the person operated the business or sporting facility in a way that was inconsistent with any guidance published on www.gov.im in relation to the operation of that business or sporting facility and, in particular, to any guidance on any action to be taken by the business or sporting facility for the purpose of reducing the risk of a person being infected with Coronavirus as a result of being present at the premises of that business or sporting facility or transacting business with a person from that business or sporting facility.¹⁹

- (13) Veterinary surgeries
- (14) Petrol filling stations
- (15) Car rental businesses
- (16) Any taxi business
- (17) Bicycle shops concerned solely or principally with the sale or hire of bicycles and related products
- (18) Garages and workshops for the repair of vehicles
- (19) Laundrettes and dry cleaners
- (20) Any post office within the meaning of the Post Office Act 1993
- (21) Any bank, building society, short-term loan provider, credit union or cash dispensing points
- (22) Any other financial service or insurance business
- (23) Any business principally concerned with information and communication technology
- (24) Legal and accounting businesses
- (25) Any business providing corporate services
- (26) Any car park, if its use is for the purpose of —
 - (a) facilitating a business permitted to operate under these Regulations;

- (b) facilitating the user of a hospital or any medical service, or facilitating any employee or user of a hospital or any medical service; or
 - (c) facilitating the operation of any other essential service within the meaning of regulation 5(5)(a) of, and the Schedule to, the Emergency Powers (Prohibitions on Movement) Regulations 2020
- (27) Public toilets
 - (28) Storage and distribution facilities, including delivery drop off areas
 - (29) Outdoor and indoor markets, for the purpose of enabling the sale of any goods or services by a business described in this Part
 - (30) Shopping centres, for the purpose of enabling any business described in this Part to operate
 - (31) Funeral homes and parlours
 - (32) Any business that is an essential service within the meaning of regulation 5(5)(a) of, and the Schedule to, the Emergency Powers (Prohibitions on Movement) Regulations 2020, in so far as it is not listed in this Schedule
 - (33) Logistics and supply businesses including but not limited to those providing food, fuel and essential goods
 - (34) Transport businesses including but not limited to those providing on Island and off Island transportation services for goods and people
 - (35) Manufacturing and engineering businesses including but not limited to those providing and sourcing goods and materials for the response to the Coronavirus pandemic
 - (36) Businesses predominantly working remotely that are regulated by the Financial Services Authority and the Gambling Supervision Commission
 - (37) Any other business that is not listed in this Schedule but, to avoid doubt, excluding a sporting facility for which separate provision is made in regulation 5A or a direction made under that regulation⁵¹
