## **CHEMICAL WEAPONS SANCTIONS (APPLICATION) REGULATIONS 2020<sup>1</sup>**

*Approved by Tynwald: 18 November 2020  
Coming into operation in accordance with regulation 2*

---

The Council of Ministers makes the following Regulations under section 19 of, and Schedule 4 to, the European Union and Trade Act 2019.

### **1 Title**

These Regulations are the Chemical Weapons Sanctions (Application) Regulations 2020.

### **2 Commencement**

If approved by Tynwald, these Regulations come into operation on IP completion day<sup>1</sup>.

### **3 Interpretation**

In these Regulations, “IP completion day” has the same meaning as in the European Union and Trade Act 2019.

### **4 Application of Chemical Weapons (Sanctions) (EU Exit) Regulations 2019**

- (1) The Chemical Weapons (Sanctions) (EU Exit) Regulations 2019<sup>2</sup> (“the applied legislation”) apply to the Island, as part of the law of the Island, subject to the exceptions, modifications and adaptations specified in the Schedule.
- (2) The text of the applied legislation is annexed to these Regulations.

## 5 Application of the Sanctions and Anti-Money Laundering Act 2018

Subject to the modifications set out in sub-paragraphs (a) and (b), the following provisions of the Sanctions and Anti-Money Laundering Act 2018 apply to the Island, as part of the law of the Island, for the purposes of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019, as they have effect in the Island by these Regulations —

- (a) section 43 (guidance about regulations under section 1), except that —
  - (i) the reference to subsection (1) of that section to regulations under section 1 is to be read as a reference to the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019, as they have effect in the Island by these Regulations; and
  - (ii) the reference in subsection (1) of that section to the appropriate Minister who made the regulations is to be read as a reference to the Treasury; and
- (b) section 53 (saving for prerogative powers), except that the reference in that section to the United Kingdom is to be read as a reference to the Isle of Man.

## 6 Revocations

The following instruments are revoked —

- (1) the European Union (Chemical Weapons Sanctions) Order 2018<sup>3</sup>; and
- (2) the Chemical Weapons Sanctions Regulations 2018<sup>4</sup>.

## SCHEDULE

## EXCEPTIONS, MODIFICATIONS AND ADAPTATIONS OF THE APPLIED LEGISLATION

**1 General**

In this Schedule, a reference to a numbered regulation or Schedule (without more) is a reference to that regulation or Schedule so numbered of the applied legislation.

**2 Specific modifications to the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019**

- (1) The applied legislation is modified as follows.
- (2) In regulation 1 (citation and commencement) —
  - (a) in the heading, omit “and commencement”; and
  - (b) omit paragraph (2).
- (3) After regulation 1 (citation and commencement), insert —

**1A Crown application**

For the avoidance of doubt, nothing in these Regulations affects Her Majesty in Her private capacity (within the meaning of the Crown Proceedings Act 1947<sup>5</sup> (of Parliament))<sup>6</sup>.

- (4) In regulation 2 (interpretation) —
  - (a) in the definition of “the Act”, after “2018”, insert <sup>7</sup>(of Parliament)<sup>8</sup>;
  - (b) after the definition of “arrangement”, insert —

- “*economic resources*” means assets of every kind, whether tangible or intangible, movable or immovable, which are not funds but can be used to obtain funds, goods or services;<sup>9</sup>
- (e) in the definition of “the EU Chemical Weapons Regulation”, for “as it has effect in EU law immediately before exit day” substitute “as it has effect in the Isle of Man immediately before IP completion day<sup>9</sup>”.
- (f) after the definition of “the EU Chemical Weapons Regulation”, insert —
- “*financial products*” means —
- (a) money market instruments (including cheques, bills and certificates of deposit);
  - (b) foreign exchange;
  - (c) derivative products (including futures and options);
  - (d) exchange rate and interest rate instruments (including products such as swaps and forward rate agreements);
  - (e) transferable securities;
  - (f) other negotiable instruments and financial assets (including bullion);
- “*financial services*” means any service of a financial nature, including (but not limited to) —
- (a) insurance-related services consisting of —
    - (i) direct life assurance;
    - (ii) direct insurance other than life assurance;
    - (iii) reinsurance and retrocession;
    - (iv) insurance intermediation, such as brokerage and agency;
    - (v) services auxiliary to insurance, such as consultancy, actuarial, risk assessment and claim settlement services;
  - (b) banking and other financial services consisting of —
    - (i) accepting deposits and other repayable funds;
    - (ii) lending (including consumer credit, mortgage credit, factoring and financing of commercial transactions);
    - (iii) financial leasing;

- (iv) payment and money transmission services (including credit, charge and debit cards, travellers' cheques and bankers' drafts);
- (v) providing guarantees or commitments;
- (vi) financial trading;
- (vii) participating in issues of any kind of securities (including underwriting and placement as an agent, whether publicly or privately) and providing services related to such issues;
- (viii) money brokering;
- (ix) asset management, such as cash or portfolio management, all forms of collective investment management, pension fund management, custodial, depository and trust services;
- (x) settlement and clearing services for financial assets (including securities, derivative products and other negotiable instruments);
- (xi) providing or transferring financial information, and financial data processing or related software (but only by suppliers of other financial services);
- (xii) providing advisory and other auxiliary financial services in respect of any activity listed in sub-paragraphs (i) to (xi) (including credit reference and analysis, investment and portfolio research and advice, advice on acquisitions and on corporate restructuring and strategy).

*“financial trading”* means trading for own account or for account of customers, whether on an investment exchange, in an over-the-counter market or otherwise, in financial products;

*“funds”* means financial assets and benefits of every kind, including (but not limited to) –

- (a) cash, cheques, claims on money, drafts, money orders and other payment instruments;
- (b) deposits, balances on accounts, debts and debt obligations;
- (c) publicly and privately traded securities and debt instruments, including stocks and shares, certificates representing securities, bonds, notes, warrants, debentures and derivative products;

- (d) interest, dividends and other income on or value accruing from or generated by assets;
  - (e) credit, rights of set-off, guarantees, performance bonds and other financial commitments;
  - (f) letters of credit, bills of lading and bills of sale;
  - (g) documents providing evidence of an interest in funds or financial resources;
  - (h) any other instrument of export finance;
- “*international obligation*” means an obligation of the United Kingdom and the Isle of Man created or arising by or under any international agreement;
- “*IP completion day*” has the meaning given in the Interpretation Act 2015 (of Tynwald)<sup>10</sup>;
- “*Island person*” means —
- (a) a British citizen, a British overseas territories citizen, a British National (Overseas) or a British overseas citizen who is resident in the Isle of Man;
  - (b) a person who under the British Nationality Act 1981 (of Parliament)<sup>11</sup> is a British subject who is resident in the Isle of Man;
  - (c) a British protected person within the meaning of that Act who is resident in the Isle of Man;
  - (d) a body incorporated under the law of the Isle of Man;
- “*person*” includes (in addition to an individual and a body of persons corporate or unincorporate) any organisation and any association or combination of persons;<sup>12</sup>
- (g) omit the definition of “prohibited activity related to chemical weapons”;
  - (h) after the omitted definition of “prohibited activity related to chemical weapons”, insert —
- <sup>13</sup> “*Public Services Commission*” means the Public Services Commission established by the Public Services Commission Act 2015 (of Tynwald)<sup>12</sup>;
- “*standard scale*” means the standard scale contained in section 55 of the Interpretation Act 2015 (of Tynwald)<sup>13</sup>;
- “*territorial sea*” (without more) means the territorial sea adjacent to the Isle of Man;

- “*Treasury*” has the meaning given in the Interpretation Act 2015 (of Tynwald)<sup>14</sup>; **22**;
- (i) omit the definition of “United Kingdom person”;
- (j) number the existing text as paragraph (1); and
- (k) after paragraph (1), insert –
- 23**(2) In these Regulations, all references to Manx legislation (within the meaning of section 9 of the Interpretation Act 2015 (of Tynwald)<sup>15</sup>) shall be construed as references to that legislation as amended from time to time. **22**.
- (5) In regulation 3 (application of prohibitions and requirements outside the United Kingdom) –
- (a) in the heading, for “United Kingdom”, substitute **23** Isle of Man **22**;
- (b) in paragraphs (1) and (4), for “A United Kingdom person”, substitute **23** An Island person **22**;
- (c) in paragraphs (1), (4) and (7), for “the United Kingdom”, wherever occurring, substitute **23** the Isle of Man **22**;
- (d) in paragraphs (2) and (5), for “the territorial sea”, wherever occurring, substitute **23** the Isle of Man or in the territorial sea **22**; and
- (e) in paragraph (7), for “Nothing”, substitute **23** For the avoidance of doubt, nothing **22**.
- (6) In regulation 4 (purposes), for “the regulations contained in this instrument that are made under section 1 of the Act”, substitute **23** these Regulations **22**.
- (7) Omit regulation 5 (power to designate persons)
- (8) Omit regulation 6 (designation criteria).
- (9) For regulation 8 (notification and publicity where designation power used), substitute –
- 23**8. **Requirement to publish a list of designated persons**
- (1) Subject to paragraph (2), the Treasury must –
- (a) publish a list of designated persons; and
- (b) keep the list up to date.
- (2) Where, in accordance with regulation 8 (notification and publicity where designation power used) (as it has effect in the United Kingdom) the Secretary of State is not required to publicise generally a designation, variation or revocation, the Treasury must not include in the list under paragraph (1) any details of that designation, variation or revocation.

- (3) The Treasury may publish the list under paragraph (1) in any form the Treasury considers appropriate, including by means of a website.
- (4) For the purpose of this regulation, “designated person” means any person for the time being designated by the Secretary of State under regulation 5 of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament).<sup>16</sup>
- (10) In regulation 9 (confidential information in certain cases where designation power used) —
- (a) in the heading, omit “where designation power used”;
- (b) omit paragraph (1);
- (c) in paragraph 2(a), for “that is to be treated as confidential in accordance with paragraph (1)”, substitute **10** which the Secretary of State has specified is to be treated as confidential under regulation 9(1) of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament)<sup>17</sup>;
- (d) in paragraph 4(c), for “enactment”, substitute **10** Manx legislation (within the meaning of section 9 of the Interpretation Act 2015 (of Tynwald)<sup>16</sup>); and
- (e) omit paragraphs (7) and (8).
- (11) For regulation 10 (meaning of “designated person” in Part 3), substitute —
- 10. Meaning of “designated person” in Part 3**
- In this Part a “*designated person*” means a person who is designated by the Secretary of State from time to time under regulation 5 of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament)<sup>17</sup> for the purposes of regulations 11 to 15 of those Regulations, and cognate expressions shall be construed accordingly, and cognate expressions shall be construed accordingly.
- Note:*
- Under provisions of the Sanctions and Anti-Money Laundering Act 2018 (of Parliament)<sup>18</sup>, a person’s designation may be varied or revoked. Any such variation or revocation would have effect in the Isle of Man.*<sup>18</sup>
- (12) For regulation 17 (immigration), substitute —
- 17. Immigration**
- A person who is designated by the Secretary of State from time to time under regulation 5 of the Chemical Weapons (Sanctions) (EU

Exit) Regulations 2019 (of Parliament)<sup>19</sup> for the purposes of regulation 17 of those Regulations is an excluded person for the purposes of section 8B of the Immigration Act 1971 (of Parliament)<sup>20</sup> (as it has effect in the Isle of Man)<sup>21</sup>. **22**

(13) In regulation 18 (finance: exceptions from prohibitions) —

- (a) omit paragraph (6);
- (b) in paragraph (7), for the definition of “relevant institution”, substitute —

**23** “*relevant institution*” means —

- (a) a person who is licensed under the Financial Services Act 2008 (of Tynwald)<sup>22</sup> to carry on a regulated activity within the meaning of section 3 of that Act;
- (b) a person who is authorised or registered under the Insurance Act 2008 (of Tynwald)<sup>23</sup> or holds a permit under that Act;
- (c) a person who is registered under the Moneylenders Act 1991 (of Tynwald)<sup>24</sup> to carry on the business of lending money;
- (d) a person who is acting as a trustee or an administrator of a retirement benefits scheme within the meaning of the Retirement Benefits Schemes Act 2008 (of Tynwald)<sup>25</sup>. **24**; and

(c) omit paragraph (8).

(14) For regulation 18A (finance: exception for authorised conduct in a relevant country), substitute —

**25** **18A. Exception for authorised conduct outside the Isle of Man**

- (1) Where a person’s conduct outside the Isle of Man would, in the absence of this paragraph, contravene a prohibition in any of regulations 11 to 15 (asset-freeze etc.) (“the relevant prohibition”), the relevant prohibition is not contravened if the conduct is authorised by a licence issued under regulation 20 (Treasury licences), as it has effect in the United Kingdom.

- (2) Where a person's conduct in a relevant country would, in the absence of this paragraph, contravene the relevant prohibition, the relevant prohibition is not contravened if the conduct is authorised by a licence or other authorisation which is issued —
- (a) under the law of the relevant country; and
  - (b) for the purpose of disapplying a prohibition in that jurisdiction which corresponds to the relevant prohibition.
- (3) In this regulation, “relevant country” means —
- (a) any of the Channel Islands;
  - (b) any British overseas territory. **22**.
- (15) For regulation 19 (exception for acts done for purposes of national security or prevention of serious crime), substitute —
- 19. Exception for acts done for purposes of national security or prevention of serious crime**
- (1) Where an act would, in the absence of this paragraph, be prohibited by regulation 9(2) (confidentiality) or any prohibition in Part 3 (Finance), that prohibition does not apply to the act if the act is one which —
- (a) a UK responsible officer has determined would be in the interests of national security or the prevention or detection of serious crime in the United Kingdom or elsewhere; or
  - (b) an Island responsible officer has determined would be in the interests of the prevention or detection of serious crime in the Isle of Man or elsewhere.
- (2) Where, in the absence of this paragraph, a thing would be required to be done under or by virtue of a provision of Part 6 (Information and records), that requirement does not apply if —
- (a) a UK responsible officer has determined that not doing the thing in question would be in the interests of national security or the prevention or detection of serious crime in the United Kingdom or elsewhere; or
  - (b) an Island responsible officer has determined that not doing the thing in question would be in the interests of the prevention or detection of serious crime in the Isle of Man or elsewhere.
- (3) In this regulation —
- “*Island responsible officer*” means a person —

- (a) in the service of the Crown or holding office under the Crown in the Isle of Man;
  - (b) appointed by the Public Services Commission; or
  - (c) appointed as a constable by the Department of Home Affairs,
- acting in the course of that person's duty;

“UK responsible officer” means a person in the service of the Crown or holding office under the Crown in the United Kingdom, acting in the course of that person's duty. <sup>26</sup>

- (16) In regulation 20 (Treasury licences), in paragraph (2), for “the Treasury consider”, substitute <sup>26</sup>the Treasury considers <sup>26</sup>.
- (17) In regulation 21 (licences: general provisions) for paragraphs (5) to (7), substitute —
- <sup>26</sup>(5) The Treasury may vary, revoke or suspend a licence at any time.
  - (6) If the Treasury issues, varies, revokes or suspends a licence which authorises acts by a particular person, the Treasury must give written notice to that person of the issue, variation, revocation or suspension of the licence.
  - (7) If the Treasury issues, varies, revokes or suspends a general licence or a licence which authorises acts by persons of a particular description, the Treasury must take such steps as it considers appropriate to publicise the issue, variation, revocation or suspension of the licence. <sup>26</sup>.
- (18) In regulation 23 (section 8B(1) to (3) of Immigration Act 1971: directions) —
- (a) for paragraph (1), substitute —
    - <sup>26</sup>(1) Any direction of the Secretary of State from time to time under regulation 23 of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament)<sup>26</sup> that section 8B(1) and (2) of the Immigration Act 1971 (as it has effect in the United Kingdom)<sup>27</sup>, or section 8B(3) of that Act (as it has effect there), have effect subject to specified exceptions in relation to any person whose name is specified or who is of a specified description, has the same effect in the Isle of Man and references to section 8B(1), (2), or (3) of the Immigration

Act 1971 (of Parliament) shall be construed as references to those subsections as they have effect in the Isle of Man<sup>28</sup>.

*Note:*

*Under provisions of the Sanctions and Anti-Money Laundering Act 2018 (of Parliament) (2018 Chapter 13) a direction may be varied, revoked or suspended. Any such variation, revocation or suspension would have effect in the Isle of Man. 22; and*

- (b) omit paragraphs (2) to (5).
- (19) In regulation 24 (finance: reporting obligations) —
- (a) in paragraph (5), omit sub-paragraph (b) and the preceding “, or” in sub-paragraph (a);
- (b) in paragraph (7), for the definition of “relevant firm”, substitute —
- 23** “relevant firm” means —
- (a) a business in the regulated sector within the meaning of Schedule 4 to the Proceeds of Crime Act 2008 (of Tynwald)<sup>29</sup> (see in particular paragraph 2 of that Schedule);
- (b) a person engaged in the business of making, supplying, selling (including selling by auction) or exchanging articles made from gold, silver, platinum, palladium, precious stones or pearls;**22**; and
- (c) after paragraph (7), insert —
- 24**(8) For the purposes of paragraph (a) of the definition of “relevant firm” in paragraph (7), the definition of “estate agent” in Schedule 4 to the Proceeds of Crime Act 2008 (of Tynwald) is to be read as if references to the sale or proposed sale of land in section 15 of the Estate Agents Act 1975 (of Tynwald)<sup>30</sup> included references to the sale or proposed sale of land outside the Isle of Man. **22**.
- (20) Omit regulation 25 (“relevant firm”).
- (21) In regulation 26 (finance: powers to request information), in paragraphs (4) and (6), for “the Treasury believe”, in both places, substitute **23** the Treasury believes **22**;
- (22) In regulation 27 (finance: production of documents) in paragraphs (2) and (3), for “the Treasury request”, in both places, substitute **23** the Treasury requests **22**.

- (23) In regulation 28 (finance: information offences), in paragraph (1)(d), for “their”, substitute **“its”**.
- (24) In regulation 29 (disclosure of information) —
- (a) in paragraph (1), for “The Secretary of State or the Treasury”, substitute **“The Treasury”**;
- (b) in paragraph (2) —
- (i) after sub-paragraph (c), insert —
- “(ca) taking any action with a view to instituting, or otherwise for the purposes of, any proceedings in the Isle of Man for an offence under any provisions of these Regulations;”**;
- (ii) in sub-paragraph (d)(i), after “Regulations”, insert **“(as they have effect in the United Kingdom)”**;
- (iii) in sub-paragraph (e), omit “, the Isle of Man”;
- (iv) omit the footnote at the end of sub-paragraph (f); and
- (v) in sub-paragraph (g), for “United Kingdom”, substitute **“Isle of Man”**; and
- (c) for paragraph (3), substitute —
- “(3) Information referred to in paragraph (1) may be disclosed to the following persons —**
- (a) a police officer;
- (b) any person holding or acting in any office under or in the service of —
- (i) the Government of the Isle of Man;
- (ii) the Crown in right of the Government of the United Kingdom;
- (iii) the Crown in right of the Scottish Government, the Northern Ireland Executive or the Welsh Government;
- (iv) the States of Jersey, Guernsey or Alderney or the Chief Pleas of Sark; or
- (v) the Government of any British overseas territory;
- (c) any law officer of the Crown in any of the British Islands;
- (d) the Legal Aid Agency in England and Wales, the Scottish Legal Aid Board or the Legal Services Agency Northern Ireland;
- (e) the Isle of Man Financial Services Authority and any body of any other part of the British Islands exercising an equivalent function;

- (f) any other regulatory body (whether or not in the Isle of Man);
  - (g) any organ of the United Nations;
  - (h) any person in the service of the United Nations, the Council of the European Union, the European Commission or the European External Action Service;
  - (i) the Government of any country;
  - (j) any other person where the Treasury considers that it is appropriate to disclose the information. **22**.
- (25) In regulation 30 (Part 6: supplementary) –
- (a) for paragraph (2), substitute –
    - 22**(2) But nothing in that regulation authorises a disclosure –
      - (a) that contravenes the data protection legislation;
      - (b) of intercepted material that is not otherwise permitted under the safeguards arrangements relating to a warrant issued under the Interception of Communications Act 1988 (of Tynwald)<sup>31</sup>. **22**;
  - (b) in paragraph (3), for “counsel or solicitor”, substitute **22**an advocate or lawyer **22**; and
  - (c) in paragraph (6) –
    - (i) for the definition of “the data protection legislation”, substitute –
      - 22**“*the data protection legislation*” has the meaning given in regulation 5(1) of the GDPR and LED Implementing Regulations 2018 (of Tynwald)<sup>32</sup>; **22**; and
    - (ii) in the definition of “privileged information”, omit “(in Scotland, to confidentiality of communications)”.
- (26) For regulation 31 (penalties for offences), substitute –
- 22**31 **Penalties for offences**
    - (1) A person guilty of an offence under any provision of Part 3 (finance) or regulation 22 (finance: licensing offences), is liable –
      - (a) on summary conviction, to custody for a term not exceeding 12 months or to a fine not exceeding level 5 on the standard scale, or to both;

#### **Citation and commencement**

1. (1) These Regulations may be cited as the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019.

**1A For the avoidance of doubt, nothing in these Regulations affects Her Majesty in Her private capacity (within the meaning of the Crown Proceedings Act 1947<sup>36</sup> (of Parliament)).**

#### **Interpretation**

2. (1) In these Regulations—
- “the Act” means the Sanctions and Anti-Money Laundering Act 2018 **(of Parliament)**<sup>37</sup>;

  - “the Chemical Weapons Convention” means the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on their Destruction, signed at Paris on 13 January 1993<sup>39</sup>;
  - “conduct” includes acts and omissions;
  - “**country**” includes any territory, region or other place;
  - “**Department of Home Affairs**” means the **Department of Home Affairs of the Isle of Man established under section 1 of the Government Departments Act 1987 (of Tynwald)**<sup>40</sup>;
  - “document” includes information recorded in any form and, in relation to information recorded otherwise than in legible form, references to its production include producing a copy of the information in legible form;

**“economic resources” means assets of every kind, whether tangible or intangible, movable or immovable, which are not funds but can be used to obtain funds, goods or services;**

**“the EU Chemical Weapons Regulation” means Council Regulation (EU) No 2018/1542 of 15 October 2018, concerning restrictive measures against the proliferation and use of chemical weapons<sup>41</sup>, as it has effect in EU law immediately before exit day as it has effect in the Isle of Man immediately before IP completion day<sup>42</sup>;**

**“financial products” means —**

- (a) money market instruments (including cheques, bills and certificates of deposit);**
- (b) foreign exchange;**
- (c) derivative products (including futures and options);**
- (d) exchange rate and interest rate instruments (including products such as swaps and forward rate agreements);**
- (e) transferable securities;**
- (f) other negotiable instruments and financial assets (including bullion);**

**“financial services” means any service of a financial nature, including (but not limited to) —**

- (a) insurance-related services consisting of —**
  - (i) direct life assurance;**
  - (ii) direct insurance other than life assurance;**
  - (iii) reinsurance and retrocession;**
  - (iv) insurance intermediation, such as brokerage and agency;**
  - (v) services auxiliary to insurance, such as consultancy, actuarial, risk assessment and claim settlement services;**
- (b) banking and other financial services consisting of —**
  - (i) accepting deposits and other repayable funds;**
  - (ii) lending (including consumer credit, mortgage credit, factoring and financing of commercial transactions);**
  - (iii) financial leasing;**
  - (iv) payment and money transmission services (including credit, charge and debit cards, travellers’ cheques and bankers’ drafts);**
  - (v) providing guarantees or commitments;**
  - (vi) financial trading;**
  - (vii) participating in issues of any kind of securities (including underwriting and placement as an agent, whether publicly or privately) and providing services related to such issues;**
  - (viii) money brokering;**
  - (ix) asset management, such as cash or portfolio management, all forms of collective investment management, pension fund management, custodial, depository and trust services;**
  - (x) settlement and clearing services for financial assets (including securities, derivative products and other negotiable instruments);**
  - (xi) providing or transferring financial information, and financial data processing or related software (but only by suppliers of other financial services);**

- (xii) providing advisory or other auxiliary financial services in respect of any activity listed in sub-paragraphs (i) to (xi) (including credit reference and analysis, investment and portfolio research and advice, advice on acquisitions and on corporate restructuring and strategy);

**“financial trading”** means trading for own account or for account of customers, whether on an investment exchange, in an over-the-counter market or otherwise, in financial products;

**“funds”** means financial assets and benefits of every kind, including (but not limited to) —

- (a) cash, cheques, claims on money, drafts, money orders and other payment instruments;
- (b) deposits, balances on accounts, debts and debt obligations;
- (c) publicly and privately traded securities and debt instruments, including stocks and shares, certificates representing securities, bonds, notes, warrants, debentures and derivative products;
- (d) interest, dividends and other income on or value accruing from or generated by assets;
- (e) credit, rights of set-off, guarantees, performance bonds and other financial commitments;
- (f) letters of credit, bills of lading and bills of sale;
- (g) documents providing evidence of an interest in funds or financial resources;
- (h) any other instrument of export finance;

**“international obligation”** means an obligation of the United Kingdom and the Isle of Man created or arising by or under any international agreement;

**“IP completion day”** has the meaning given in the Interpretation Act 2015 (of Tynwald)<sup>43</sup>;

**“Island person”** means —

- (a) a British citizen, a British overseas territories citizen, a British National (Overseas) or a British overseas citizen who is resident in the Isle of Man;
- (b) a person who under the British Nationality Act 1981 (of Parliament) is a British subject who is resident in the Isle of Man;
- (c) a British protected person within the meaning of that Act who is resident in the Isle of Man;
- (d) a body incorporated under the law of the Isle of Man;

**“person”** includes (in addition to an individual and a body of persons corporate or unincorporate) any organisation and any association or combination of persons;

- ~~(a) — developing, producing, acquiring, possessing, transporting, stockpiling, or retaining chemical weapons;~~
- ~~(b) — directly or indirectly transferring chemical weapons to any person;~~

- ~~(d) — engaging in preparations for the use of chemical weapons;~~

**“Public Services Commission”** means the Public Services Commission established by the Public Services Commission Act 2015 (of Tynwald)<sup>44</sup>;

(2) Any person may contravene a relevant prohibition by conduct in the ~~territorial sea~~ **the Isle of Man or in the territorial sea**.

### **Purpose**

### **Designation of persons**

5. ~~(1) The Secretary of State may designate persons, by name, for the purposes of any of the following—~~

- ~~(a) regulations 11 to 15 (Finance);~~
- ~~(b) regulation 17 (Immigration).~~

~~(2) The Secretary of State may designate different persons for the purposes of different provisions mentioned in paragraph (1).~~

#### **Designation criteria**

6. ~~(1) The Secretary of State may not designate a person under regulation 5 unless the Secretary of State—~~

- ~~(a) has reasonable grounds to suspect that that person is an involved person, and~~

- (b) — considers that the designation of that person is appropriate, having regard to—
  - (i) — the purpose stated in regulation 4, and
  - (ii) — the likely significant effects of the designation on that person (as they appear to the Secretary of State to be on the basis of the information that the Secretary of State has).
- (2) — In this regulation an “involved person” means a person who—
  - (a) — is or has been involved in a prohibited activity related to chemical weapons,
  - (b) — is owned or controlled directly or indirectly (within the meaning of regulation 7) by a person who is or has been so involved,
  - (c) — is acting on behalf of or at the direction of a person who is or has been so involved, or
  - (d) — is a member of, or associated with, a person who is or has been so involved.
- (3) — Any reference in this regulation to being involved in a prohibited activity related to chemical weapons includes being so involved in whatever way and wherever any actions constituting the involvement take place, and in particular includes—
  - (a) — being responsible for, engaging in, providing support for, or promoting, a prohibited activity related to chemical weapons;
  - (b) — providing financial services, or making available funds or economic resources, that could contribute to a prohibited activity related to chemical weapons;
  - (c) — being involved in assisting the contravention or circumvention of any relevant provision.
- (4) — In this regulation, “relevant provision” means—
  - (a) — any provision of Part 3 (Finance);
  - (b) — any provision of the law of a country other than the United Kingdom made for purposes corresponding to a purpose of any provision of Part 3 (Finance).
- (5) — Nothing in any sub-paragraph of paragraph (3) is to be taken to limit the meaning of any of the other sub-paragraphs of that paragraph.

**Meaning of “owned or controlled directly or indirectly”**

- 7. (1) A person who is not an individual (“C”) is “owned or controlled directly or indirectly” by another person (“P”) if either of the following two conditions is met (or both are met).
- (2) The first condition is that P—
  - (a) holds directly or indirectly more than 50% of the shares in C,
  - (b) holds directly or indirectly more than 50% of the voting rights in C, or
  - (c) holds the right directly or indirectly to appoint or remove a majority of the board of directors of C.
- (3) Schedule 1 contains provision applying for the purpose of interpreting paragraph (2).
- (4) The second condition is that it is reasonable, having regard to all the circumstances, to expect that P would (if P chose to) be able, in most cases or in significant respects, by whatever means and whether directly or indirectly, to achieve the result that affairs of C are conducted in accordance with P’s wishes.

**Notification and publicity where designation power used**

- 8. (1) Paragraph (2) applies where the Secretary of State—
  - (a) has made a designation under regulation 5, or
  - (b) has by virtue of section 22 of the Act varied or revoked a designation made under that regulation.
- (2) The Secretary of State—
  - (a) must without delay take such steps as are reasonably practicable to inform the designated person of the designation, variation or revocation, and
  - (b) must take steps to publicise the designation, variation or revocation.

- (3) — The information given under paragraph (2)(a) where a designation is made must include a statement of reasons.
- (4) — In this regulation a “statement of reasons”, in relation to a designation, means a brief statement of the matters that the Secretary of State knows, or has reasonable grounds to suspect, in relation to the designated person which have led the Secretary of State to make the designation.
- (5) — Matters that would otherwise be required by paragraph (4) to be included in a statement of reasons may be excluded from it where the Secretary of State considers that they should be excluded—
- (a) — in the interests of national security or international relations,
  - (b) — for reasons connected with the prevention or detection of serious crime in the United Kingdom or elsewhere, or
  - (c) — in the interests of justice.
- (6) — The steps taken under paragraph (2)(b) must—
- (a) — unless one or more of the restricted publicity conditions is met, be steps to publicise generally—
    - (i) — the designation, variation or revocation, and
    - (ii) — in the case of a designation, the statement of reasons;
  - (b) — if one or more of those conditions is met, be steps to inform only such persons as the Secretary of State considers appropriate of the designation, variation or revocation and (in the case of a designation) of the contents of the statement of reasons.
- (7) — The “restricted publicity conditions” are as follows—
- (a) — the designation is of a person believed by the Secretary of State to be an individual under the age of 18;
  - (b) — the Secretary of State considers that disclosure of the designation, variation or revocation should be restricted—
    - (i) — in the interests of national security or international relations,
    - (ii) — for reasons connected with the prevention or detection of serious crime in the United Kingdom or elsewhere, or
    - (iii) — in the interests of justice.
- (8) — Paragraph (9) applies if—
- (a) — when a designation is made, one or more of the restricted publicity conditions is met, but
  - (b) — at any time when the designation has effect, it becomes the case that none of the restricted publicity conditions is met.
- (9) — The Secretary of State must—
- (a) — take such steps as are reasonably practicable to inform the designated person that none of the restricted publicity conditions is now met, and
  - (b) — take steps to publicise generally the designation and the statement of reasons relating to it.

#### **Requirement to publish a list of designated persons**

- 8. (1) Subject to paragraph (2), the Treasury must—**
- (a) publish a list of designated persons, and**
  - (b) keep the list up to date.**
- (2) Where, in accordance with regulation 8 (notification and publicity where designation power used) (as it has effect in the United Kingdom) the Secretary of State is not required to publicise generally a designation, variation or revocation, the Treasury must not include in the list under paragraph (1) any details of that designation, variation or revocation.**
- (3) The Treasury may publish the list under paragraph (1) in any form the Treasury considers appropriate, including by means of a website.**
- (4) For the purpose of this regulation, “designated person” means any person for the time being designated by the Secretary of State under regulation 5 of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament).**

### **Confidential information in certain cases where designation power used**

9. (1) ~~Where the Secretary of State in accordance with regulation 8(6)(b) informs only certain persons of a designation, variation or revocation and (in the case of a designation) of the contents of the statement of reasons, the Secretary of State may specify that any of that information is to be treated as confidential.~~

(2) A person ("P") who—

(a) is provided with information that is to be treated as confidential in accordance with paragraph (1) **which the Secretary of State has specified is to be treated as confidential under regulation 9(1) of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament),** or

(b) otherwise obtains such information,

must not, subject to paragraph (3), disclose it if P knows, or has reasonable cause to suspect, that the information is to be treated as confidential.

(3) The prohibition in paragraph (2) does not apply to any disclosure made by P with lawful authority.

(4) For this purpose information is disclosed with lawful authority only if and to the extent that—

(a) the disclosure is by, or is authorised by, the Secretary of State,

(b) the disclosure is by or with the consent of the person who is or was the subject of the designation,

(c) the disclosure is necessary to give effect to a requirement imposed under or by virtue of these Regulations or any other enactment **Manx legislation (within the meaning of section 9 of the Interpretation Act 2015 (of Tynwald)<sup>48</sup>,** or

(d) the disclosure is required, under rules of court, tribunal rules or a court or tribunal order, for the purposes of legal proceedings of any description.

(5) This regulation does not prevent the disclosure of information that is already, or has previously been, available to the public from other sources.

11. (1) A person ("P") must not deal with funds or economic resources owned, held or controlled by a designated person if P knows, or has reasonable cause to suspect, that P is dealing with such funds or economic resources.
- (2) Paragraph (1) is subject to Part 5 (Exceptions and licences).
- (3) A person who contravenes the prohibition in paragraph (1) commits an offence.
- (4) For the purposes of paragraph (1), a person "deals with" funds if the person—
  - (a) uses, alters, moves, transfers or allows access to the funds,
  - (b) deals with the funds in any other way that would result in any change in volume, amount, location, ownership, possession, character or destination, or
  - (c) makes any other change, including portfolio management, that would enable use of the funds.
- (5) For the purposes of paragraph (1), a person "deals with" economic resources if the person—
  - (a) exchanges the economic resources for funds, goods or services, or
  - (b) uses the economic resources in exchange for funds, goods or services (whether by pledging them as security or otherwise).
- (6) The reference in paragraph (1) to funds or economic resources that are "owned, held or controlled" by a person includes, in particular, a reference to—
  - (a) funds or economic resources in which the person has any legal or equitable interest, regardless of whether the interest is held jointly with any other person and regardless of whether any other person holds an interest in the funds or economic resources;
  - (b) any tangible property (other than real property), or bearer security, that is comprised in funds or economic resources and is in the possession of the person.
- (7) For the purposes of paragraph (1), funds or economic resources are to be treated as owned, held or controlled by a designated person if they are owned, held or controlled by a person who is owned or controlled directly or indirectly (within the meaning of regulation 7) by the designated person.
- (8) For the avoidance of doubt, the reference in paragraph (1) to a designated person includes P if P is a designated person.

#### **Making funds available to designated persons**

12. (1) A person ("P") must not make funds available directly or indirectly to a designated person if P knows, or has reasonable cause to suspect, that P is making the funds so available.
- (2) Paragraph (1) is subject to Part 5 (Exceptions and licences).
- (3) A person who contravenes the prohibition in paragraph (1) commits an offence.
- (4) The reference in paragraph (1) to making funds available indirectly to a designated person includes, in particular, a reference to making them available to a person who is owned or controlled directly or indirectly (within the meaning of regulation 7) by the designated person.

#### **Making funds available for benefit of designated persons**

13. (1) A person ("P") must not make funds available to any person for the benefit of a designated person if P knows, or has reasonable cause to suspect, that P is making the funds so available.
- (2) Paragraph (1) is subject to Part 5 (Exceptions and licences).
- (3) A person who contravenes the prohibition in paragraph (1) commits an offence.
- (4) For the purposes of this regulation—
  - (a) funds are made available for the benefit of a designated person only if that person thereby obtains, or is able to obtain, a significant financial benefit, and
  - (b) "financial benefit" includes the discharge (or partial discharge) of a financial obligation for which the designated person is wholly or partly responsible.

#### **Making economic resources available to designated persons**

14. (1) A person ("P") must not make economic resources available directly or indirectly to a designated person if P knows, or has reasonable cause to suspect—
- (a) that P is making the economic resources so available, and
  - (b) that the designated person would be likely to exchange the economic resources for, or use them in exchange for, funds, goods or services.
- (2) Paragraph (1) is subject to Part 5 (Exceptions and licences).
- (3) A person who contravenes the prohibition in paragraph (1) commits an offence.
- (4) The reference in paragraph (1) to making economic resources available indirectly to a designated person includes, in particular, a reference to making them available to a person who is owned or controlled directly or indirectly (within the meaning of regulation 7) by the designated person.

#### **Making economic resources available for benefit of designated persons**

15. (1) A person ("P") must not make economic resources available to any person for the benefit of a designated person if P knows, or has reasonable cause to suspect, that P is making the economic resources so available.
- (2) Paragraph (1) is subject to Part 5 (Exceptions and licences).
- (3) A person who contravenes the prohibition in paragraph (1) commits an offence.
- (4) For the purposes of paragraph (1)—
- (a) economic resources are made available for the benefit of a designated person only if that person thereby obtains, or is able to obtain, a significant financial benefit, and
  - (b) "financial benefit" includes the discharge (or partial discharge) of a financial obligation for which the designated person is wholly or partly responsible.

#### **Circumventing etc prohibitions**

16. (1) A person must not intentionally participate in activities knowing that the object or effect of them is, whether directly or indirectly—
- (a) to circumvent any of the prohibitions in regulations 11 to 15, or
  - (b) to enable or facilitate the contravention of any such prohibition.
- (2) A person who contravenes the prohibition in paragraph (1) commits an offence.

### **PART 4**

#### **Immigration**

##### **Immigration**

17. — A person who is designated under regulation 5 for the purposes of this regulation is an excluded person for the purposes of section 8B of the Immigration Act 1971.

**17. A person who is designated by the Secretary of State from time to time under regulation 5 of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament)<sup>51</sup> for the purposes of regulation 17 of those Regulations is an excluded person for the purposes of section 8B of the Immigration Act 1971 (or Parliament)<sup>52</sup> (as it has effect in the Isle of Man)<sup>53</sup>.**

### **PART 5**

#### **Exceptions and licences**

##### **Finance: exceptions from prohibitions**

18. (1) The prohibition in regulation 11 (asset-freeze in relation to designated persons) is not contravened by an independent person ("P") transferring to another person a legal or equitable interest in funds or economic resources where, immediately before the transfer, the interest—
- (a) is held by P, and
  - (b) is not held jointly with the designated person.
- (2) In paragraph (1) "independent person" means a person who—
- (a) is not the designated person, and

(b) is not owned or controlled directly or indirectly (within the meaning of regulation 7) by the designated person.

(3) The prohibitions in regulations 11 to 13 (asset-freeze in relation to, and making funds available to, or for the benefit of, designated persons) are not contravened by a relevant institution crediting a frozen account with interest or other earnings due on the account.

(4) The prohibitions in regulations 12 and 13 (making funds available to, or for the benefit of, designated persons) are not contravened by a relevant institution crediting a frozen account where it receives funds transferred to that institution for crediting to that account.

(5) The prohibitions in regulations 12 and 13 are not contravened by the transfer of funds to a relevant institution for crediting to an account held or controlled (directly or indirectly) by a designated person, where those funds are transferred in discharge (or partial discharge) of an obligation which arose before the date on which the person became a designated person.

~~(6) The prohibitions in regulations 11 to 13 are not contravened in relation to a designated person ("P") by a transfer of funds from account A to account B, where —~~

~~(a) account A is with a relevant institution which carries on an excluded activity within the meaning of section 142D of the Financial Services and Markets Act 2000,~~

~~(b) account B is with a ring-fenced body within the meaning of section 142A of the Financial Services and Markets Act 2000, and~~

~~(c) accounts A and B are held or controlled (directly or indirectly) by P.~~

(7) In this regulation—

"designated person" has the same meaning as it has in Part 3 (Finance);

"frozen account" means an account with a relevant institution which is held or controlled (directly or indirectly) by a designated person;

~~"relevant institution" means a person that has permission under Part 4A of the Financial Services and Markets Act 2000 (permission to carry on regulated activity);~~

**"relevant institution" means —**

**(a) a person who is licensed under the Financial Services Act 2008 (of Tynwald)<sup>54</sup> to carry on a regulated activity within the meaning of section 3 of that Act;**

**(b) a person who is authorised or registered under the Insurance Act 2008 (of Tynwald)<sup>55</sup> or who holds a permit under that Act;**

**(c) a person who is registered under the Moneylenders Act 1991 (of Tynwald)<sup>56</sup> to carry on the business of lending money;**

**(d) a person who is acting as a trustee or an administrator of a retirement benefits scheme within the meaning of the Retirement Benefits Schemes Act 2008 (of Tynwald)<sup>57</sup>.**

~~(8) The definition of "relevant institution" in paragraph (7) is to be read with section 22 of the Financial Services and Markets Act 2000, any relevant order under that section and Schedule 2 to that Act.~~

**Finance: exception for authorised conduct in a relevant country**

18A. (1) Where a person's conduct in a relevant country would, in the absence of this regulation, contravene a prohibition in any of regulations 11 to 15 (asset-freeze etc.) ("the relevant prohibition"), the relevant prohibition is not contravened if the conduct is authorised by a licence or other authorisation which is issued —

(a) under the law of the relevant country, and

(b) for the purpose of disapplying a prohibition in that jurisdiction which corresponds to the relevant prohibition.

(2) In this regulation —

"relevant country" means —

(a) any of the Channel Islands,

**Exception for authorised conduct outside the Isle of Man**

**18A. (1) Where a person’s conduct outside the Isle of Man would, in the absence of this paragraph, contravene a prohibition in any of regulations 11 to 15 (asset-freeze etc.) (“the relevant prohibition”), the relevant prohibition is not contravened if the conduct is authorised by a licence issued under regulation 20 (Treasury licences), as it has effect in the United Kingdom.**

**(2) Where a person’s conduct in a relevant country would, in the absence of this paragraph, contravene the relevant prohibition, the relevant prohibition is not contravened if the conduct is authorised by a licence or other authorisation which is issued —**

- (a) under the law of the relevant country, and**
- (b) for the purpose of disappling a prohibition in that jurisdiction which corresponds to the relevant prohibition.**

**(3) In this regulation, “relevant country” means —**

- (a) any of the Channel Islands;**
- (b) any British overseas territory.**

**Exception for acts done for purposes of national security or prevention of serious crime**

- ~~(b) — the prevention or detection of serious crime in the United Kingdom or elsewhere.~~

~~(3) — In this regulation “responsible officer” means a person in the service of the Crown or holding office under the Crown, acting in the course of that person’s duty.~~

**(1) Where an act would, in the absence of this paragraph, be prohibited by regulation 9(2) (confidentiality) or any prohibition in Part 3 (Finance), that prohibition does not apply to the act if the act is one which—**

- (a) a UK responsible officer has determined would be in the interests of national security or the prevention or detection of serious crime in the United Kingdom or elsewhere; or**
- (b) an Island responsible officer has determined would be in the interests of the prevention or detection of serious crime in the Isle of Man or elsewhere.**

**(2) Where, in the absence of this paragraph, a thing would be required to be done under or by virtue of a provision of Part 6 (Information and records), that requirement does not apply if—**

- (a) a UK responsible officer has determined that not doing the thing in question would be in the interests of national security or the prevention or detection of serious crime in the United Kingdom or elsewhere; or**
- (b) an Island responsible officer has determined that not doing the thing in question would be in the interests of the prevention or detection of serious crime in the Isle of Man or elsewhere.**

**(3) In this regulation—**

**“Island responsible officer” means a person—**

- (a) in the service of the Crown or holding office under the Crown in the Isle of Man,**
- (b) appointed by the Public Services Commission, or**
- (c) appointed as a constable by the Department of Home Affairs, acting in the course of that person’s duty;**

**“UK responsible officer” means a person in the service of the Crown or holding office under the Crown in the United Kingdom, acting in the course of that person’s duty.**

**Treasury licences**

20. (1) The prohibitions in regulations 11 to 15 (asset-freeze etc) do not apply to anything done under the authority of a licence issued by the Treasury under this paragraph.

(2) The Treasury may issue a licence which authorises acts by a particular person only where ~~the Treasury consider~~ **the Treasury considers** that it is appropriate to issue the licence for a purpose set out in Schedule 2.

**Licences: general provisions**

21. (1) This regulation applies in relation to Treasury licences.

(2) A licence must specify the acts authorised by it.

(3) A licence may be general or may authorise acts by a particular person or persons of a particular description.

(4) A licence may—

- (a) contain conditions;
- (b) be of indefinite duration or a defined duration.

~~(5) A person who issues a licence may vary, revoke or suspend it at any time.~~

~~(6) A person who issues, varies, revokes or suspends a licence which authorises acts by a particular person must give written notice to that person of the issue, variation, revocation or suspension of the licence.~~

~~(7) A person who issues, varies, revokes or suspends a general licence or a licence which authorises acts by persons of a particular description must take such steps as that person considers appropriate to publicise the issue, variation, revocation or suspension of the licence.~~

**(5) The Treasury may vary, revoke or suspend a licence at any time.**

**(6) If the Treasury issues, varies, revokes or suspends a licence which authorises acts by a particular person, the Treasury must give written notice to that person of the issue, variation, revocation or suspension of the licence.**

**(7) If the Treasury issues, varies, revokes or suspends a general licence or a licence which authorises acts by persons of a particular description, the Treasury must take such steps as it considers appropriate to publicise the issue, variation, revocation or suspension of the licence.**

**Finance: licensing offences**

22. (1) A person (“P”) commits an offence if P knowingly or recklessly—

- (a) provides information that is false in a material respect, or
- (b) provides or produces a document that is not what it purports to be,

for the purpose of obtaining a Treasury licence (whether for P or anyone else).

(2) A person who purports to act under the authority of a Treasury licence but who fails to comply with any condition of the licence commits an offence.

**Section 8B(1) to (3) of Immigration Act 1971: directions**

23. (1) ~~The Secretary of State may direct that, in relation to any person within regulation 17 whose name is specified, or who is of a description specified, section 8B(1) and (2) of the Immigration Act 1971, or section 8B(3) of that Act, have effect subject to specified exceptions.~~



(1) Any direction of the Secretary of State from time to time under regulation 23 of the Chemical Weapons (Sanctions) (EU Exit) Regulations 2019 (of Parliament)<sup>58</sup> that section 8B(1) and (2) of the Immigration Act 1971 (as it has effect in the United Kingdom)<sup>59</sup>, or section 8B(3) of that Act (as it has effect there), have effect subject to specified exceptions in relation to any person whose name is specified or who is of a specified description, has the same effect in the Isle of Man and references to section 8B(1), (2), or (3) of the Immigration Act 1971 (of Parliament) shall be construed as references to those subsections as they have effect in the Isle of Man<sup>60</sup>.

*Note: Under provisions of the Sanctions and Anti-Money Laundering Act 2018 (of Parliament) (2018 Chapter 13) a direction may be varied, revoked or suspended. Any such variation, revocation or suspension would have effect in the Isle of Man.*

(6) In this regulation "specified" means specified in a direction.

## PART 6

### Information and records

#### Finance: reporting obligations

24. (1) A relevant firm must inform the Treasury as soon as practicable if—
- (a) it knows, or has reasonable cause to suspect, that a person—
    - (i) is a designated person, or
    - (ii) has committed an offence under any provision of Part 3 (Finance) or regulation 22 (finance: licensing offences), and
  - (b) the information or other matter on which the knowledge or cause for suspicion is based came to it in the course of carrying on its business.
- (2) Where a relevant firm informs the Treasury under paragraph (1), it must state—
- (a) the information or other matter on which the knowledge or suspicion is based, and
  - (b) any information it holds about the person by which the person can be identified.
- (3) Paragraph (4) applies if—
- (a) a relevant firm informs the Treasury under paragraph (1) that it knows, or has reasonable cause to suspect, that a person is a designated person, and
  - (b) that person is a customer of the relevant firm.
- (4) The relevant firm must also state the nature and amount or quantity of any funds or economic resources held by it for the customer at the time when it first had the knowledge or suspicion.
- (5) A relevant institution must inform the Treasury without delay if that institution—
- (a) credits a frozen account in accordance with regulation 18(4) (finance: exceptions from prohibitions), or
  - ~~(b) transfers funds from a frozen account in accordance with regulation 18(6).~~
- (6) A person who fails to comply with a requirement in paragraph (1), (2) or (4) commits an offence.
- (7) In this regulation—

"frozen account" has the same meaning as it has in regulation 18;

"relevant firm" is to be read in accordance with regulation 25;

**"relevant firm" means —**

- (a) **a business in the regulated sector within the meaning of Schedule 4 to the Proceeds of Crime Act 2008 (of Tynwald)<sup>61</sup> (see in particular paragraph 2 of that Schedule);**
- (b) **a person engaged in the business of making, supplying, selling (including selling by auction) or exchanging articles made from gold, silver, platinum, palladium, precious stones or pearls;**

"relevant institution" has the same meaning as it has in regulation 18.

**(8) For the purposes of paragraph (a) of the definition of "relevant firm" in paragraph (7), the definition of "estate agent" in Schedule 4 to the Proceeds of Crime Act 2008 (of Tynwald) is to be read as if references to the sale or proposed sale of land in section 15 of the Estate Agents Act 1975 (of Tynwald)<sup>62</sup> included references to the sale or proposed sale of land outside the Isle of Man.**

**"Relevant firm"**

25. (1) The following are relevant firms for the purposes of regulation 24—

- (a) a person that has permission under Part 4A of the Financial Services and Markets Act 2000 (permission to carry on regulated activity);
- (b) an undertaking that by way of business—
  - (i) operates a currency exchange office;
  - (ii) transmits money (or any representation of monetary value) by any means, or
  - (iii) cashes cheques that are made payable to customers;
- (c) a firm or sole practitioner that is—
  - (i) a statutory auditor within the meaning of Part 42 of the Companies Act 2006 (statutory auditors), or
  - (ii) a local auditor within the meaning of section 4(1) of the Local Audit and Accountability Act 2014 (general requirements for audit);
- (d) a firm or sole practitioner that provides to other persons, by way of business—
  - (i) accountancy services;
  - (ii) legal or notarial services;
  - (iii) advice about tax affairs, or
  - (iv) trust or company services within the meaning of paragraph (2);
- (e) a firm or sole practitioner that carries out, or whose employees carry out, estate agency work;
- (f) the holder of a casino operating licence within the meaning given by section 65(2)(a) of the Gambling Act 2005 (nature of a licence);
- (g) a person engaged in the business of making, supplying, selling (including selling by auction) or exchanging—
  - (i) articles made from gold, silver, platinum or palladium, or
  - (ii) precious stones or pearls.

(2) In paragraph (1), "trust or company services" means any of the following services—

- (a) forming companies or other legal persons;
- (b) acting, or arranging for another person to act—
  - (i) as a director or secretary of a company;
  - (ii) as a partner of a partnership, or
  - (iii) in a similar capacity in relation to other legal persons;

**Finance: powers to request information**

26. (1) The Treasury may request a designated person to provide information about—
- (a) funds or economic resources owned, held or controlled by, or on behalf of, the designated person, or
  - (b) any disposal of such funds or economic resources.
- (2) The Treasury may request a designated person to provide such information as the Treasury may reasonably require about expenditure—
- (a) by the designated person, or
  - (b) for the benefit of the designated person.
- (3) For the purposes of paragraph (2), expenditure for the benefit of a designated person includes expenditure on the discharge (or partial discharge) of a financial obligation for which the designated person is wholly or partly responsible.
- (4) The power in paragraph (1) or (2) is exercisable only where ~~the Treasury believe~~ **the Treasury believes** that it is necessary for the purpose of monitoring compliance with or detecting evasion of any provision of Part 3 (Finance).
- (5) The Treasury may request a person acting under a Treasury licence to provide information about—
- (a) funds or economic resources dealt with under the licence, or
  - (b) funds or economic resources made available under the licence.
- (6) The Treasury may request a person to provide information within paragraph (7) if ~~the Treasury believe~~ **the Treasury believes** that the person may be able to provide the information.

(7) Information within this paragraph is such information as the Treasury may reasonably require for the purpose of—

- (a) establishing for the purposes of any provision of Part 3 (Finance)—
  - (i) the nature and amount or quantity of any funds or economic resources owned, held or controlled by, or on behalf of, a designated person,
  - (ii) the nature and amount or quantity of any funds or economic resources made available directly or indirectly to, or for the benefit of, a designated person, or
  - (iii) the nature of any financial transactions entered into by a designated person;
- (b) monitoring compliance with or detecting evasion of—
  - (i) any provision of Part 3 (Finance),
  - (ii) regulation 24 (finance: reporting obligations), or
  - (iii) any condition of a Treasury licence;
- (c) detecting or obtaining evidence of the commission of an offence under Part 3 or regulation 22 (finance: licensing offences) or 24 (finance: reporting obligations).

(8) The Treasury may specify the way in which, and the period within which, information is to be provided.

(9) If no such period is specified, the information which has been requested must be provided within a reasonable time.

(10) A request may include a continuing obligation to keep the Treasury informed as circumstances change, or on such regular basis as the Treasury may specify.

(11) Information requested under this regulation may relate to any period of time during which a person is, or was, a designated person.

(12) Information requested by virtue of paragraph (1)(b), (2) or (7)(a)(iii) may relate to any period before a person became a designated person (as well as, or instead of, any subsequent period).

(13) Expressions used in this regulation have the same meaning as they have in Part 3.

#### **Finance: production of documents**

27. (1) A request under regulation 26 may include a request to produce specified documents or documents of a specified description.

(2) Where ~~the Treasury request~~ **the Treasury requests** that documents be produced, the Treasury may—

- (a) take copies of or extracts from any document so produced,
  - (b) request any person producing a document to give an explanation of it, and
  - (c) where that person is a body corporate, partnership or unincorporated body other than a partnership, request any person who is—
    - (i) in the case of a partnership, a present or past partner or employee of the partnership, or
    - (ii) in any other case, a present or past officer or employee of the body concerned,
- to give such an explanation.

(3) Where ~~the Treasury request~~ **the Treasury requests** a designated person or a person acting under a Treasury licence to produce documents, that person must—

- (a) take reasonable steps to obtain the documents (if they are not already in the person's possession or control);
- (b) keep the documents under the person's possession or control (except for the purpose of providing them to the Treasury or as the Treasury may otherwise permit).

(4) In this regulation "designated person" has the same meaning as it has in Part 3 (Finance).

#### **Finance: information offences**

28. (1) A person commits an offence if that person—

- (a) without reasonable excuse, refuses or fails within the time and in the manner specified (or, if no time has been specified, within a reasonable time) to comply with any request under regulation 26 (finance: powers to request information);
- (b) knowingly or recklessly gives any information, or produces any document, which is false in a material particular in response to such a request;
- (c) with intent to evade any provision of regulation 26 (finance: powers to request information) or 27 (finance: production of documents), destroys, mutilates, defaces, conceals or removes any document;
- (d) otherwise intentionally obstructs the Treasury in the exercise of ~~their~~ **its** powers under regulation 26 or 27.

(2) Where a person is convicted of an offence under this regulation, the court may make an order requiring that person, within such period as may be specified in the order, to comply with the request.

#### **Disclosure of information**

29. (1) ~~The Secretary of State or the Treasury~~ **The Treasury** may, in accordance with this regulation, disclose—

- (a) any information obtained under or by virtue of Part 5 (Exceptions and licences) or this Part, or
- (b) any information held in connection with—
  - (i) anything done under or by virtue of Part 2 (Designation of persons)—or Part 3 (Finance), or
  - (ii) any exception or licence under Part 5 or anything done in accordance with such an exception or under the authority of such a licence.

(2) Information referred to in paragraph (1) may be disclosed for, or in connection with, any of the following purposes—

- (a) the exercise of functions under these Regulations;
- (b) the purpose stated in regulation 4;
- (c) facilitating, monitoring or ensuring compliance with these Regulations;
- (ca) taking any action with a view to instituting, or otherwise for the purposes of, any proceedings in the Isle of Man for an offence under any provisions of these Regulations;**
- (d) taking any action with a view to instituting, or otherwise for the purposes of, any proceedings in the United Kingdom —
  - (i) for an offence under any provision of these Regulations (**as they have effect in the United Kingdom**),
  - (ii) in relation to a monetary penalty under section 146 of the Policing and Crime Act 2017 (breach of financial sanctions legislation);
- (e) taking any action with a view to instituting, or otherwise for the purposes of, any proceedings in any of the Channel Islands, ~~the Isle of Man~~ or any British overseas territory, for an offence under a provision in any such jurisdiction that is similar to a provision of these Regulations;
- (f) compliance with an international obligation;
- (g) facilitating the exercise by an authority outside the ~~United Kingdom~~ **Isle of Man** or by an international organisation of functions which correspond to functions under these Regulations.

~~(3) Information referred to in paragraph (1) may be disclosed to the following persons—~~

  - (iv) the States of Jersey, Guernsey or Alderney or the Chief Pleas of Sark; or**
  - (v) the Government of any British overseas territory;**
- (c) any law officer of the Crown in any of the British Islands;**
- (d) the Legal Aid Agency in England and Wales, the Scottish Legal Aid Board or the Legal Services Agency Northern Ireland;**
- (e) the Isle of Man Financial Services Authority and any body of any other part of the British Islands exercising an equivalent function;**
- (f) any other regulatory body (whether or not in the Isle of Man);**
- (g) any organ of the United Nations;**
- (h) any person in the service of the United Nations, the Council of the European Union, the European Commission or the European External Action Service;**
- (i) the Government of any country;**
- (j) any other person where the Treasury considers that it is appropriate to disclose the information.**

(4) Information referred to in paragraph (1) may be disclosed to any person with the consent of a person who, in their own right, is entitled to the information.

(5) In paragraph (4) "in their own right" means not merely in the capacity as a servant or agent of another person.

(6) In paragraph (1)(b)—

- (a) the reference to information includes information obtained at a time when any provision of these Regulations is not in force, and
- (b) the reference to a licence under Part 5 includes—
  - (i) a licence which is treated as if it were a licence which had been issued under that Part, and
  - (ii) a licence which is deemed to have been issued under that Part.

**Part 6: supplementary**

30. (1) A disclosure of information under regulation 29 does not breach any restriction on such disclosure imposed by statute or otherwise.
- (2) ~~But nothing in that regulation authorises a disclosure that—~~
- (a) ~~contravenes the data protection legislation, or~~
  - (b) ~~is prohibited by any of Parts 1 to 7 or Chapter 1 of Part 9 of the Investigatory Powers Act 2016.~~
- (2) **But nothing in that regulation authorises a disclosure —**
- (a) **that contravenes the data protection legislation;**
  - (b) **of intercepted material that is not otherwise permitted under the safeguards arrangements relating to a warrant issued under the Interception of Communications Act 1988 (of Tynwald)<sup>63</sup>.**
- (3) Nothing in this Part is to be read as requiring a person who has acted or is acting as ~~counsel or solicitor~~ **an advocate or lawyer** for any person to disclose any privileged information in their possession in that capacity.

- (a) on summary conviction, to custody for a term not exceeding 12 months or to a fine not exceeding level 5 on the standard scale, or to both;**
- (b) on conviction on information, to custody for a term not exceeding 2 years or to a fine, or to both.**

**(3) A person guilty of an offence under regulation 24(6) or 28 (information offences in connection with Part 3) is liable on summary conviction, to custody for a term not exceeding 6 months or to a fine not exceeding level 5 on the standard scale, or to both.**

#### **Liability of officers of bodies corporate etc**

32. (1) Where an offence under these Regulations, committed by a body corporate—

- (a) is committed with the consent or connivance of any director, manager, secretary or other similar officer of the body corporate, or any person who was purporting to act in any such capacity, or
- (b) is attributable to any neglect on the part of any such person,

that person as well as the body corporate is guilty of the offence and is liable to be proceeded against and punished accordingly.

(2) In paragraph (1), “director”, in relation to a body corporate whose affairs are managed by its members, means a member of the body corporate.

(3) Paragraph (1) also applies in relation to a body that is not a body corporate, with the substitution for the reference to a director of the body of a reference—

- (a) in the case of a partnership, to a partner;
- (b) in the case of an unincorporated body other than a partnership—
  - (i) where the body’s affairs are managed by its members, to a member of the body;
  - (ii) in any other case, to a member of the governing body.

#### **Jurisdiction to try offences**

33. (1) ~~Where an offence under these Regulations is committed in the United Kingdom—~~

- ~~(a) proceedings for the offence may be taken at any place in the United Kingdom, and~~
- ~~(b) the offence may for all incidental purposes be treated as having been committed at any such place.~~



(2) Where an offence under these Regulations is committed outside the ~~United Kingdom~~ **Isle of Man**—

- (a) proceedings for the offence may be taken ~~at any place in the United Kingdom~~ **Isle of Man**, and
- (b) the offence may for all incidental purposes be treated as having been committed ~~at any such place~~ **in the Isle of Man**.

~~(3) In the application of paragraph (2) to Scotland, any such proceedings against a person may be taken—~~

- ~~(a) in any sheriff court district in which the person is apprehended or is in custody, or~~
- ~~(b) in such sheriff court district as the Lord Advocate may determine.~~

~~(4) In paragraph (3) "sheriff court district" is to be read in accordance with the Criminal Procedure (Scotland) Act 1995 (see section 307(1) of that Act).~~

**Procedure for offences by unincorporated bodies**

34. (1) Paragraphs (2) and (3) apply if it is alleged that an offence under these Regulations has been committed by an unincorporated body (as opposed to by a member of the body).

(2) Proceedings in ~~England and Wales or Northern Ireland~~ **the Isle of Man** for such an offence must be brought against the body in its own name.

~~(3) For the purposes of proceedings, for such an offence brought against an unincorporated body—~~

- ~~(a) rules of court relating to the service of documents have effect as if the body were a body corporate;~~
- ~~(b) the following provisions apply as they apply in relation to a body corporate—
  - ~~(i) section 33 of the Criminal Justice Act 1925 and Schedule 3 to the Magistrates' Courts Act 1980~~
  - ~~(ii) section 18 of the Criminal Justice Act (Northern Ireland) 1945 and Article 166 of, and Schedule 4 to, the Magistrates' Courts (Northern Ireland) Order 1981.~~~~

**(3) For the purposes of proceedings for such an offence brought against an unincorporated body section 32 of the Summary Jurisdiction Act 1989 (of Tynwald)<sup>65</sup> and rules of court relating to the service of documents apply.**

(4) A fine imposed on an unincorporated body on its conviction of an offence under these Regulations is to be paid out of the funds of the body.

**Time limit for proceedings for summary offences**

35. (1) Proceedings for an offence under these Regulations which is triable only summarily may be brought within the period of 12 months beginning with the date on which evidence sufficient in the opinion of the prosecutor **Attorney General** to justify the proceedings comes to the prosecutor's **Attorney General's** knowledge.

(2) But such proceedings may not be brought by virtue of paragraph (1) more than 3 years after the commission of the offence.

(3) A certificate signed by the prosecutor **Attorney General** as to the date on which the evidence in question came to the prosecutor's **Attorney General's** knowledge is conclusive evidence of the date on which it did so; and a certificate to that effect and purporting to be so signed is to be treated as being so signed unless the contrary is proved.

~~(4) In relation to proceedings in Scotland—~~

- ~~(a) section 136(3) of the Criminal Procedure (Scotland) Act 1995 (date of commencement of summary proceedings) applies for the purposes of this regulation as it applies for the purposes of that section, and~~

## **Application of Chapter 1 of Part 2 of Serious Organised Crime and Police Act 2005**

36. Chapter 1 of Part 2 of the Serious Organised Crime and Police Act 2005 (investigatory powers) applies to any offence under Part 3 (Finance) and regulation 22 (finance: licensing offences).

### **PART 8**

#### **Supplementary and final provision**

##### **Notices**

37. (1) This regulation applies in relation to a notice required by regulation 21 (licences: general provisions) to be given to a person.
- (2) The notice may be given to an individual—
- (a) by delivering it to the individual,
  - (b) by sending it to the individual by post addressed to the individual at his or her usual or last-known place of residence or business, or
  - (c) by leaving it for the individual at that place.
- (3) The notice may be given to a person other than an individual—
- (a) by sending it by post to the proper officer of the body at its principal office, or
  - (b) by addressing it to the proper officer of the body and leaving it at that office.
- (4) The notice may be given to the person by other means, including by electronic means, with the person's consent.
- (5) In this regulation, the reference in paragraph (3) to a "principal office"—
- (a) in relation to a registered company, is to be read as a reference to the company's registered office;
  - (b) in relation to a body incorporated or constituted under the law of a country other than the United Kingdom **Isle of Man**, includes a reference to the body's principal office in the United Kingdom **Isle of Man** (if any).
- (6) In this regulation—
- "proper officer"—
  - (a) in relation to a body other than a partnership, means the secretary or other executive officer charged with the conduct of the body's general affairs, and
  - (b) in relation to a partnership, means a partner or a person who has the control or management of the partnership business;
- "registered company" means a company registered under the enactments relating to companies for the time being in force in the United Kingdom **in operation in the Isle of Man**.

##### **Protection for acts done for purposes of compliance**

**37A. (1) A person is not liable to any civil proceedings to which that person would, in the absence of this regulation, have been liable in respect of an act if that act is done in the reasonable belief that the act is in compliance with these Regulations.**

**(2) In this regulation, "act" includes an omission.**

##### **Revocation of the Chemical Weapons Council Regulation**

38. Council Regulation (EU) No 2018/1542 of 15 October 2018, concerning restrictive measures against the proliferation and use of chemical weapons is revoked.

##### **Amendments**

39. (1) The Chemical Weapons (Asset Freezing) and Miscellaneous Amendments Regulations 2018 is amended as follows.

(2) Omit regulation 2.

(3) Omit Parts 2 to 4 and the Schedule.

##### **Transitional provision: Treasury licences**

40. (1) Paragraphs (2) to (4) apply to a licence which—
- (a) was granted, or deemed to be granted, by the Treasury under regulation 9 **regulation 5** of the 2018 Regulations,

- (b) was in effect immediately before the relevant date, and
- (c) authorises conduct which would (on and after the relevant date, and in the absence of paragraphs (2) to (4)) be prohibited under Part 3 (Finance),

and such a licence is referred to in this regulation as “an existing financial sanctions licence”.

(2) An existing financial sanctions licence which authorises an act which would otherwise be prohibited has effect on and after the relevant date as if it had been issued by the Treasury under regulation 20(1) (Treasury licences).

(3) Any reference in an existing financial sanctions licence to the 2018 Regulations is to be treated on and after the relevant date as a reference to these Regulations.

(4) Any reference in an existing financial sanctions licence to a prohibition in—

- (a) the 2018 Regulations, or
- (b) the EU Chemical Weapons Regulation,

is to be treated on and after the relevant date as a reference to the corresponding prohibition in Part 3.

(5) Paragraph (6) applies where—

- (a) an application for a licence, or for the variation of a licence, under the 2018 Regulations was made before the relevant date,
- (b) the application is for the authorisation of conduct which would (on and after the relevant date) be prohibited under Part 3, and
- (c) a decision to grant or refuse the application has not been made before that date.

(6) The application is to be treated on and after the relevant date as an application for a licence, or for the variation of a licence (as the case may be), under regulation 20(1) (Treasury licences).

41. (1) Where—

- (a) a person was named in Annex I of the EU Chemical Weapons Regulation immediately before the relevant date, and
- (b) the person is a designated person immediately before the relevant date,

any reference in a provision mentioned in paragraph (2) to the date on which a person became a designated person is a reference to the date on which the person was named in that Annex **and that Annex had effect in the Isle of Man.**

(2) The provisions referred to in paragraph (1) are—

- (a) regulation 18(5) (finance: exception from prohibitions), and
- (b) paragraphs 6(b)(i) and 9(a) of Schedule 2 (Treasury licenses: purposes).

(3) In paragraph (1)—

“designated person” has the same meaning as it has in Part 3 (Finance);

## **SCHEDULES**

### **SCHEDULE 1**

Regulation 7(3)

#### **Rules for interpretation of regulation 7(2)**

##### **Application of Schedule**

1. (1) The rules set out in the following paragraphs of this Schedule apply for the purpose of interpreting regulation 7(2).
- (2) They also apply for the purpose of interpreting this Schedule.

##### **Joint interests**

2. If two or more persons each hold a share or right jointly, each of them is treated as holding that share or right.

##### **Joint arrangements**

3. (1) If shares or rights held by a person and shares or rights held by another person are the subject of a joint arrangement between those persons, each of them is treated as holding the combined shares or rights of both of them.
- (2) A "joint arrangement" is an arrangement between the holders of shares or rights that they will exercise all or substantially all the rights conferred by their respective shares or rights jointly in a way that is pre-determined by the arrangement.
- (3) "Arrangement" has the meaning given by paragraph 12.

##### **Calculating shareholdings**

4. (1) In relation to a person who has a share capital, a reference to holding "more than 50% of the shares" in that person is to holding shares comprised in the issued share capital of that person of a nominal value exceeding (in aggregate) 50% of that share capital.
- (2) In relation to a person who does not have a share capital—
  - (a) a reference to holding shares in that person is to holding a right or rights to share in the capital or, as the case may be, profits of that person;
  - (b) a reference to holding "more than 50% of the shares" in that person is to holding a right or rights to share in more than 50% of the capital or, as the case may be, profits of that person.

##### **Voting rights**

5. (1) A reference to the voting rights in a person is to the rights conferred on shareholders in respect of their shares (or, in the case of a person not having a share capital, on members) to vote at general meetings of the person on all or substantially all matters.
- (2) In relation to a person that does not have general meetings at which matters are decided by the exercise of voting rights—
  - (a) a reference to holding voting rights in the person is to be read as a reference to holding rights in relation to the person that are equivalent to those of a person entitled to exercise voting rights in a company;
  - (b) a reference to holding "more than 50% of the voting rights" in the person is to be read as a reference to holding the right under the constitution of the person to block changes to the overall policy of the person or to the terms of its constitution.
6. In applying regulation 7(2) and this Schedule, the voting rights in a person are to be reduced by any rights held by the person itself.

##### **Rights to appoint or remove members of the board**

7. A reference to the right to appoint or remove a majority of the board of directors of a person is to the right to appoint or remove directors holding a majority of the voting rights at meetings of the board on all or substantially all matters.

8. A reference to a board of directors, in the case of a person who does not have such a board, is to be read as a reference to the equivalent management body of that person.

**Shares or rights held "indirectly"**

9. (1) A person holds a share "indirectly" if the person has a majority stake in another person and that other person—

- (a) holds the share in question, or
- (b) is part of a chain of persons—
  - (i) each of whom (other than the last) has a majority stake in the person immediately below it in the chain, and
  - (ii) the last of whom holds the share.

(2) A person holds a right "indirectly" if the person has a majority stake in another person and that other person—

- (a) holds that right, or
- (b) is part of a chain of persons—
  - (i) each of whom (other than the last) has a majority stake in the person immediately below it in the chain, and
  - (ii) the last of whom holds that right.

(3) For these purposes, a person ("A") has a "majority stake" in another person ("B") if—

- (a) A holds a majority of the voting rights in B,
- (b) A is a member of B and has the right to appoint or remove a majority of the board of directors of B,
- (c) A is a member of B and controls alone, pursuant to an agreement with other shareholders or members, a majority of the voting rights in B, or
- (d) A has the right to exercise, or actually exercises, dominant influence or control over B.

(4) In the application of this paragraph to the right to appoint or remove a majority of the board of directors, a person ("A") is to be treated as having the right to appoint a director if—

- (a) any person's appointment as director follows necessarily from that person's appointment as director of A, or
- (b) the directorship is held by A itself.

**Shares held by nominees**

10. A share held by a person as nominee for another is to be treated as held by the other (and not by the nominee).

**Rights treated as held by person who controls their exercise**

11. (1) Where a person controls a right, the right is to be treated as held by that person (and not by the person who in fact holds the right, unless that person also controls it).

(2) A person "controls" a right if, by virtue of any arrangement between that person and others, the right is exercisable only—

- (a) by that person,
- (b) in accordance with that person's directions or instructions, or
- (c) with that person's consent or concurrence.

12. "Arrangement" includes—

- (a) any scheme, agreement or understanding, whether or not it is legally enforceable, and
- (b) any convention, custom or practice of any kind.

**Rights exercisable only in certain circumstances etc**

13. (1) Rights that are exercisable only in certain circumstances are to be taken into account only—

- (a) when the circumstances have arisen, and for so long as they continue to obtain, or
- (b) when the circumstances are within the control of the person having the rights.

~~(2) But rights that are exercisable by an administrator or by creditors while a person is subject to relevant insolvency proceedings are not to be taken into account while the person is subject to those proceedings.~~

~~(3) "Relevant insolvency proceedings" means—~~

~~(a) administration within the meaning of the Insolvency Act 1986,~~

~~(b) administration within the meaning of the Insolvency (Northern Ireland) Order 1989, or~~

~~(c) proceedings under the insolvency law of another country during which a person's assets and affairs are subject to the control or supervision of a third party or creditor.~~

(4) Rights that are normally exercisable but are temporarily incapable of exercise are to continue to be taken into account.

### **Rights attached to shares held by way of security**

14. Rights attached to shares held by way of security provided by a person are to be treated for the purposes of this Schedule as held by that person—

(a) where apart from the right to exercise them for the purpose of preserving the value of the security, or of realising it, the rights are exercisable only in accordance with that person's instructions, and

(b) where the shares are held in connection with the granting of loans as part of normal business activities and apart from the right to exercise them for the purpose of preserving the value of the security, or of realising it, the rights are exercisable only in that person's interests.

## **SCHEDULE 2**

Regulation 20(2)

### **Treasury licences: purposes**

#### **Interpretation**

1. In this Schedule—

"consular post" has the same meaning as in the Vienna Convention on Consular Relations done at Vienna on 24 April 1963<sup>68</sup>, and any reference to the functions of a consular post is to be read in accordance with that Convention;

"designated person" has the same meaning as it has in Part 3 (Finance);

"diplomatic mission" and any reference to the functions of a diplomatic mission is to be read in accordance with the Vienna Convention on Diplomatic Relations done at Vienna on 18 April 1961<sup>69</sup>;

"frozen funds or economic resources" means funds or economic resources frozen by virtue of regulation 11, and any reference to a person's frozen funds or economic resources is to funds or economic resources frozen as a consequence of the designation of that person for the purpose of that regulation.

#### **Basic needs**

2. (1) To enable the basic needs of a designated person, or (in the case of an individual) any dependent family member of such a person, to be met.

(2) In the case of an individual, in sub-paragraph (1), "basic needs" includes—

(a) medical needs;

(b) needs for—

(i) food;

(ii) payment of insurance premiums;

(iii) payment of tax;

(iv) rent or mortgage payments;

(v) utility payments.

(3) In the case of a person other than an individual, in sub-paragraph (1), "basic needs" includes needs for—

(a) payment of insurance premiums;

- (b) payment of reasonable fees for the provision of property management services;
  - (c) payment of remuneration, allowances or pensions of employees;
  - (d) payment of tax;
  - (e) rent or mortgage payments;
  - (f) utility payments.
- (4) In sub-paragraph (1)—
- “dependent” means financially dependent;
  - “family member” includes—
    - (a) the wife or husband of the designated person;
    - (b) the civil partner of the designated person;
    - (c) any parent or other ascendant of the designated person;
    - (d) any child or other descendant of the designated person;
    - (e) any person who is a brother or sister of the designated person, or a child or other descendant of such a person.

**Legal services**

3. To enable the payment of—
- (a) reasonable professional fees for the provision of legal services, or
  - (b) reasonable expenses associated with the provision of legal services.

**Maintenance of frozen funds and economic resources**

4. To enable the payment of—
- (a) reasonable fees, or
  - (b) reasonable service charges,
- arising from the routine holding or maintenance of frozen funds or economic resources.

**Extraordinary expenses**

5. To enable an extraordinary expense of a designated person to be met.

**Pre-existing judicial decisions etc**

6. To enable, by the use of a designated person’s frozen funds or economic resources, the implementation or satisfaction (in whole or in part) of a judicial, administrative or arbitral decision or lien, provided that—
- (a) the funds or economic resources so used are the subject of the decision or lien,
  - (b) the decision or lien—
    - (i) was made or established before the date on which the person became a designated person, and
    - (ii) is enforceable in the ~~United Kingdom~~ **Isle of Man**, and
  - (c) the use of the frozen funds or economic resources does not directly or indirectly benefit any other designated person.

**Diplomatic missions**

7. To enable anything to be done in order that the functions of a diplomatic mission or consular post or of an international organisation enjoying immunities in accordance with international law may be carried out.

**Extraordinary situation**

8. To enable anything to be done to deal with an extraordinary situation.

**Prior obligations**

9. To enable, by the use of a designated person’s frozen funds or economic resources, the satisfaction of an obligation of that person (whether arising under a contract, other agreement or otherwise), provided that—
- (a) the obligation arose before the date on which the person became a designated person, and
  - (b) no payments are made to another designated person, whether directly or indirectly.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations are made under the Sanctions and Anti-Money Laundering Act 2018 (c.13) to establish a sanctions regime for the purpose of discouraging the proliferation and use of chemical weapons. Following the UK’s withdrawal from the European Union, these Regulations

replace the EU sanctions regime concerning restrictive measures against the proliferation and use of chemical weapons, implemented via an EU Council Decision and Regulation. The Regulations confer a power on the Secretary of State to designate persons who are, or have been, involved in the proliferation and use of chemical weapons. Designated persons may be excluded from the United Kingdom and may be made subject to financial sanctions, including having their funds and/or economic resources frozen. The Regulations provide for certain exceptions to this sanctions regime, in particular in relation to financial sanctions (for example to allow for frozen accounts to be credited with interest or other earnings) and also acts done for the purpose of national security or the prevention of serious crime. The Regulations also confer powers on the Treasury to issue licenses in respect of activities that would otherwise be prohibited under the financial sanctions imposed by these Regulations. Schedule 2 to these Regulations sets out the purposes pursuant to which the Treasury will issue such licences.

These Regulations make it a criminal offence to contravene, or circumvent, any of the prohibitions in these Regulations and prescribe the mode of trial and penalties that apply to such offences. The Regulations prescribe powers for the provision and sharing of information to enable the effective implementation and enforcement of the sanctions regime.

Council Regulation (EU) No 2018/1542 of 15 October 2018, concerning restrictive measures directed against the proliferation and use of chemical weapons is revoked by the Regulations, as are the provisions of the Chemical Weapons (Asset-Freezing) and Miscellaneous Amendments Regulations 2018 (S.I. 2018/1090) which relate to this sanctions regime.

An Impact Assessment has not been produced for these Regulations, as the instrument is intended to ensure existing sanctions remain in place following the United Kingdom's withdrawal from the European Union.
