Gas Regulation Act 1995

GAS (TARIFF FIXING) REGULATIONS 2021¹

Approved by Tynwald:

19th May 2021

Coming into Operation: in accordance with regulation 2

The Communications and Utilities Regulatory Authority, having complied with section 6(3) of the Gas Regulation Act 1995¹, makes the following Regulations under section 6 of that Act.

1 Title

These Regulations are the Gas (Tariff Fixing) Regulations 2021.

2 Commencement

If approved by Tynwald, these Regulations come into operation on the day after Tynwald approval is given².

3 Public gas supplier

The public gas supplier for the purposes of these Regulations is Manx Gas Limited³.

4 Parameters for the fixing of Tariffs

- (1) Where, as at the date on which these Regulations come into operation, a customer is subject to the tariffs set out in the Schedule (“the Scheduled tariffs”), any tariff fixed by the public gas supplier in respect of the customer must not exceed the Scheduled tariffs.
- (2) The public gas supplier shall not apply any increase to additional charges that are applied to any customers in respect of section 6(7) of the Act.

¹ Section 6(3) provides that “The Authority may impose conditions in connection with parameters set by it under this section; but, before exercising this power, must — (a) consult with the public gas supplier on whom it proposes to impose the conditions; and (b) take into consideration any feedback received in the course of that consultation”.

- (3) Where, as at the date on which these Regulations come into operation, a customer is subject to tariffs other than the Scheduled tariffs (“the existing tariffs”), any tariff fixed by the public gas supplier in respect of the customer, including on the renewal of any contract between the public gas supplier and the customer, must not exceed the existing tariffs.
