# CIVIL AVIATION (RESTRICTION OF FLYING) (TT - RED ARROWS DISPLAY) REGULATIONS 2023<sup>1</sup>

Laid before Tynwald: 25 April 2023 Coming into Operation: 8 June 2023

The Department for Enterprise makes the following Regulations under sections 11H and 11I of the Airports and Civil Aviation Act 1987.

#### 1 Title

These Regulations are the Civil Aviation (Restriction of Flying) (TT - Red Arrows Display) Regulations 2023.

#### 2 Commencement

These Regulations come into operation on 8 June 2023 and cease to have effect at the end of that day.<sup>1</sup>

## 3 Interpretation

Terms used in these Regulations have the meanings specified by the Civil Aviation (Miscellaneous Provisions) Order 2020.<sup>2</sup>

### 4 Restricted airspace

- (1) Subject to paragraph (3) the pilot in command of an aircraft must not fly the aircraft below 8,000 feet above mean sea level between 1820 and 1910 hours Universal Time Coordinated on 8 June 2023 within the airspace specified in paragraph (2).
- (2) The airspace referred to in paragraph (1) is the airspace within the area bounded by a circle of radius 6 nautical miles centred on 540928N 0042813W (Douglas Bay, Isle of Man), illustrated in the Schedule.

- (3) Paragraph (1) does not apply to the pilot in command of an aircraft
  - (a) which is for the time being operated by the Royal Air Force Aerobatic Team for the purposes of a flying display; or
  - (b) who is flying with the permission of the Department or an authorised person.
- (4) The Department or an authorised person may grant permission under paragraph (3) subject to such conditions as the Department or authorised person may specify.

#### 5 Offences and Penalties

- (1) Subject to paragraph (2) a person who contravenes the requirement imposed under regulation 4(1) commits an offence and is liable—
  - (a) on summary conviction, to a fine not exceeding level 5 on the standard scale; or
  - (b) on conviction on information, to a fine or to a term of custody not exceeding five years, or both.
- (2) If it is proved that an act or omission of a person that would otherwise have been a contravention by the person of a provision specified in paragraph (1) was due to any cause not avoidable by the exercise of reasonable care by the person, the act or omission is to be taken not to be a contravention by the person of the provision.


