## **STATUTORY BOARDS (ANNUAL SUMS) ORDER 2024<sup>1</sup>**

*Approved by Tynwald: 20 February 2024*  
*Coming into operation in accordance with article 2*

The Treasury, after consulting<sup>1</sup> the Tynwald Management Committee<sup>2</sup>, makes the following Order under section 2(1) and (2) of the Payment of Members' Expenses Act 1989.

### **1 Title**

This Order is the Statutory Boards (Annual Sums) Order 2024.

### **2 Commencement**

- (1) If approved by Tynwald, this Order comes into operation as follows<sup>3</sup>.
- (2) This Order operates from 1 April 2023<sup>4</sup>.

### **3 Annual sums to be paid to members of certain Statutory Boards who are not members of Tynwald**

- (1) In relation to each Statutory Board specified in column 1 of table 1 in Schedule 1 the amount specified in column 2 opposite is prescribed as the annual sum which the Treasury shall pay to each member of that Statutory Board (other than the Chairman) who is not a member of Tynwald subject to any residential qualification specified in column 3 opposite.

<sup>1</sup> Under section 6(3) of the Payment of Members' Expenses Act 1989, before making an order under section 6(1) of that Act, the Treasury shall consult such committee of Tynwald or other body as the Governor in Council may by order designate for the purpose of section 6(3) of that Act, and where an order under section 6(1) of that Act departs from any recommendation made by such committee or body, the Treasury shall lay before Tynwald a statement setting out those recommendations and its reasons for departing from them.

<sup>3</sup> Under section 7(4) of the Payment of Members' Expenses Act 1989 this Order shall not have effect unless it is approved by Tynwald.

<sup>4</sup> Under section 7(4) of the Payment of Members' Expenses Act 1989 this Order shall operate from such date as may be specified in the Order (which may be before, on or after the date of making the Order).

- (2) In relation to each Statutory Board specified in column 1 of table 2 in Schedule 1 the amount specified in column 2 opposite is prescribed as the annual sum which the Treasury shall pay to the Chairman of that Statutory Board who is not a member of Tynwald.

#### **4 Annual sums to be paid to members of the Isle of Man Gambling Supervision Commission**

- (1) In relation to the Isle of Man Gambling Supervision Commission, in respect of the annual period specified in column 1 of table 1 in Schedule 2, the amount specified in column 2 opposite is prescribed as the annual sum which the Treasury shall pay to each member of that Statutory Board (other than the Chairman).
- (2) In relation to the Isle of Man Gambling Supervision Commission, in respect of the annual period specified in column 1 of table 2 in Schedule 2, the amount specified in column 2 opposite is prescribed as the annual sum which the Treasury shall pay to the Chairman of that Statutory Board.

#### **5 Revocation**

The Statutory Boards (Annual Sums) Order 2015 is revoked<sup>5</sup>.
