## CABINET OFFICE (LEGISLATIVE AMENDMENTS) ACT 2014

*Signed in Tynwald:* 21 October 2014

**AN ACT** to make amendments to enactments consequential upon renaming the Chief Secretary's Office as the Cabinet Office.

**BE IT ENACTED** by the Queen's Most Excellent Majesty, by and with the advice and consent of the Council and Keys in Tynwald assembled, and by the authority of the same, as follows:—

### **1 Short title**

The short title of this Act is the Cabinet Office (Legislative Amendments) Act 2014.

### **2 Jury Act 1980 amended**

In Part I of Schedule 1 to the Jury Act 1980 (persons ineligible for jury service), in Group C (others concerned with the administration of justice), in the entry relating to the Chief Secretary, for “Chief Secretary's Office” substitute **“Cabinet Office”**.

### **3 Regulation of Surveillance etc Act 2006 amended**

In the Schedule to the Regulation of Surveillance etc Act 2006 (public authorities), in paragraph 8, for “Chief Secretary's Office” substitute **“Cabinet Office”**.

### **4 Personal Liability (Ministers, Members and Officers) Act 2007 amended**

In section 3(2)(g) of the Personal Liability (Ministers, Members and Officers) Act 2007 (liability of designated persons), for “Chief Secretary's Office” substitute **“Cabinet Office”**.

## 5 Tynwald Commissioner for Administration Act 2011 amended

In paragraph 1(j) of Schedule 2 to the Tynwald Commissioner for Administration Act 2011 (listed authorities), for “Chief Secretary’s Office” substitute **“Cabinet Office”**.

## 6 Consequential amendments

- (1) Without limiting section 2 to 5, a reference in any enactment to the Chief Secretary’s Office is to be taken as a reference to the Cabinet Office.
- (2) In subsection (1), “enactment” includes —
  - (a) an Act;
  - (b) a public document; and
  - (c) any legislation of the United Kingdom, or any part of it, that applies to the Island —
    - (i) expressly or by implication (with or without modification);
    - (ii) by virtue of an Order in Council; or
    - (iii) by virtue of an Act of Tynwald or a provision made under an Act of Tynwald.

## 7 Expiry

- (1) Sections 2 to 5 cease to have effect on the day following the promulgation of this Act.
- (2) Subsection (1) does not affect the continuing validity of the amendments made by sections 2 to 5.
