A MEASURE enacted pursuant to the Church Legislation Procedure Act 1993 to extend to the Island certain provisions of the Ecclesiastical Jurisdiction and Care of Churches Measure 2018; and for connected purposes

1. Short title

The short title of this Measure is the Ecclesiastical Jurisdiction and Care of Churches Measure (Isle of Man) 2019.

2. Commencement

This Measure comes into operation on such day or days as the Bishop may by order appoint.

3. Extension of provisions of 2018 Measure to the Isle of Man

Parts 1 and 3 to 6 of the Ecclesiastical Jurisdiction and Care of Churches Measure 2018 extend to the Island subject to the exceptions, adaptations and modifications specified in Schedule 1.

4. Consequential amendments and repeals

- (1) The enactments specified in Schedule 2 are amended in accordance with that Schedule.
- (2) The enactments specified in Schedule 3 are repealed to the extent specified in column 3 of that Schedule.
